

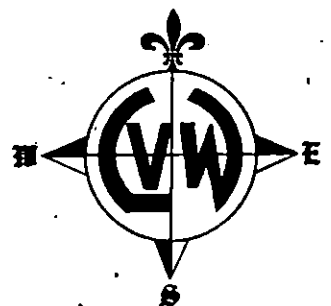

S. Tozzi thanked all the volunteers who helped with the Thanksgiving dinner held at Willow Hall. Twenty-five people were served and dinners were delivered to three residents who were shut-ins.

S. Nordell moved to approve the November 4, 2015 and November 18, 2015 minutes. C. Frattini seconded. All in favor. Motion carried.

S. Tozzi moved to approve the amended **Parking Policy**. R. Steenweg moved to table this motion. C. Lupo seconded. All in favor. Motion carried.

Manager's Report

J. Schultz spoke about fire safety and the use of space heaters. He said the Association does not allow the use of space heaters inside the units.

The staff looked into a License Plate Recognition system for the two visitor entrance gates at Route 70 and Route 37 gates. This purchase of \$13,644.00 will be voted on at the January 6 Board meeting

Work will begin on the two back bathrooms and stage bathroom in Encore after the first of the year. The Board will vote on this \$86,828.74 expense at the January 6th Board meeting.

A purchase for six-wireless microphones will be voted on at the January 6th Board meeting for \$10,629.88

The equipment is back into the Nautilus Room and the gym will open soon.
