# THE BALLOT



- **ABSENTEE BALLOTS ARE ANONYMOUS.**
  
- **PROXY – CONVEYING YOUR VOTING RIGHTS –**
  - IF YOU PREVIOUSLY DESIGNATED A RESIDENT IN YOUR UNIT TO VOTE IN YOUR PLACE –  
\***NO ACTION IS NECESSARY.**
  - IF YOU HAVE NOT YET DESIGNATED & YOU WISH TO CONVEY YOUR VOTING RIGHTS TO A RESIDENT RESIDING IN YOUR UNIT,  
\***PLEASE CALL THE ASSOCIATION OFFICES AT 732-657-9595 OR EMAIL THE ASSOCIATION@LVWA.NET.**
  - REQUESTS MUST BE MADE NO LATER THAN THE CLOSE OF BUSINESS, FRIDAY, AUGUST 4, 2023.
  
- **YOU OWN MULTIPLE UNITS – OWNER OF MULTIPLE UNITS ARE REQUESTED TO INCLUDE ONLY ONE BALLOT IN EACH RETURN ENVELOPE**
  
- **SPLIT BALLOTS – ARE AVAILABLE UPON REQUEST BY CONTACTING THE ASSOCIATIONS OFFICES AT 732-657-9595 OR EMAILING ASSOCIATION@LVWA.NET**
  
- **LOST/ MISPLACED BALLOT/CHANGE YOUR VOTE – YOU CAN ASK FOR A NEW BALLOT BY CONTACTING THE ASSOCIATION OFFICES.**

- **ABSENTEE BALLOTS** - MUST BE CAST BY AUGUST 31, 2023 BY 1 PM (EDST) EITHER VIA MAIL, IN A BALLOT BOX LOCATED IN THE ASSOCIATION OFFICES DURING BUSINESS HOURS. OR ON ELECTION DAY, POLLS WILL OPEN AT 10 AM ON ELECTION DAY.
- **PROXIES\*** – CAN BE WITHDRAWN UP TO 1 PM (EDST) ON ELECTION DAY.
- **CHANGE YOUR VOTE\*** - YOU CAN COME IN AND REQUEST TO CHANGE YOUR VOTE UP TO 1 PM (EDST) .
- **QUORUM (898 BALLOTS)** – IF A QUORUM IS MET, SCANNING AND COUNTING WILL BEGIN BY THE ELECTION COMMITTEE. IF QUORUM IS NOT MET, THE ANNUAL MEETING WILL BE ADJOURNED FOR 30 DAYS.
