## Board of Trustees Meeting- April 21, 2021

### Zoom Conference

The meeting was called to order at 1:00 PM by Board President, Louis Maiocco.

PRESENT: Trustees: Board President - Louis Maiocco, Vice President – Fay Weinstein, Treasurer - Al DAmato, Secretary - Joyce Carmody, Trustee - Eugene Murphy, Trustee - Thomas Hardman and Trustee - Wayne Steinman.

Management Staff: Community Manager – Joseph Schultz, Service Manager – Jim Snyder, Accounting Administrator – Michelle O’Connor and Recreation Director – Mary Lighthipe.

The Recreation report was given by the Recreation Director, M. Lighthipe.

ITEMS VOTED ON: (continued in New Business)

J. Carmody moved to waive the reading of the minutes. W. Steinman seconded. There was no discussion and a vote was taken. All in favor. Motion carried.

J. Carmody moved to approve the April 7, 2021 minutes. E. Murphy seconded. There was no discussion and a vote was taken. All in favor. Motion carried.

W. Steinman moved to the insurance program with Mitchell Insurance Services for 2021-2022 in the amount of \$1,265,352.38 which compares to \$1,184,670.45 expiring, an increase of \$80,681.93, with all terms and conditions renewing as per expiring, to accept the rate level agreement for a two-year period at no cost and to purchase 20 million in property limits at a cost of \$35,400.00. These expenses will be charged to GL#8100 - Insurance Expense. J. Carmody seconded. There was no discussion and a vote was taken.

A.DAmato moved to approve the installation of two ADA bathrooms at the Willow Hall pool by converting the building formerly used by Hotwire Communications, for a cost not to exceed \$29,000.00. The funds to meet this expense will be provided by account # 3230 - Capital Replacement/ Common Buildings. W. Steinman seconded. There was no discussion and a vote was taken. All in favor. Motion carried.

T. Hardman moved to contract with It’s All Good Construction for the 2021 roofing project for a total cost of \$688,538.50. This expense will be provided by account #3270 - Capital Replacement/ Roofs. J. Carmody seconded. Question from Trustee regarding added expenses.

Motion carried.

F. Weinstein moved to contract with All County Exteriors to purchase and install vinyl cedar shakes and windows for Willow Hall at a cost of \$70,000.20 along with in-house costs of \$6,200.00 for a total project cost of \$76,200.20. The funds to meet this expense will be provided by account #3230 - Capital Replacement/Common Buildings. W. Steinman seconded. Discussion ensued clarifying the cost difference for this project which was previously mentioned at the last open Board meeting. A vote was taken and all were in favor. Motion carried.

E. Murphy moved to contract with ATI A Trubuilders, Inc. for the Club Encore Greenery Room Renovation at a cost not to exceed \$110,000.00. The funds to meet this expense will be provided by account #3230 - Capital Replacement/Common Buildings. A.DAmato seconded. There was no discussion and a vote was taken. All in favor. Motion carried.

A.DAmato moved to contract with ATI A Trubuilders, Inc. for the Club Encore flooring at a cost of \$39,111.84. The funds to meet this expense will be provided by account # 3230 - Capital Replacement/Common Buildings. E. Murphy seconded. It was explained how costs were able to remain low for this project. A vote was taken and all were in favor. Motion carried.

T. Hardman moved to approve revisions for Specification 2\_9, “Installation of New Construction Windows for Encore Models”. E. Murphy seconded. There was no discussion and a vote was taken. All in favor. Motion carried.

T. Hardman moved to approve revisions for Specification 1\_1, “Landscaping in the Five-Foot Area by Resident”. J. Carmody seconded. There was no discussion and a vote was taken. All in favor. Motion carried.

E. Murphy moved to approve revisions for Policy regarding “Vehicle Use and Vehicle Parking”. T. Hardman seconded. There was no discussion and a vote was taken. All in favor. Motion carried.

W. Steinman moved to approve Policy Resolution regarding “Board Member Conduct and Confidentiality”. T. Hardman seconded. There was no discussion and a vote was taken. All in favor. Motion carried.

There were no Committee reports.

### COMMUNITY MANAGER’S REPORT:

The Attorneys are still working out the fine details of the contract for the remote entry system for the Colonial gate. The Fitness Center is well underway and the electrical work is near completion.

J. Snyder stated that the Board of Trustees adopted a change to the Azek project that if a unit has wood cedar shakes, maintenance is now replacing those wood shakes with vinyl shakes while performing the Azek project. Due to this change to the original Azek project, maintenance will need to go back to 70 completed Azek units with wood cedar shakes and replace those shakes with vinyl shakes. The following are the costs:

Management is recommending to contract with It's All Good Construction to install 68 squares of vinyl impression shakes on 70 units for a cost of \$56,950.00, with funding to be provided by available PPP funds. The Board will vote on this at the next open Board meeting on May 5, 2021.

As previously stated in the Manager's Corner of the March LVW magazine and open Board meetings, the Association must verify the members' ages every two years to keep the exempt status as per the Housing for Older Persons Act (or known as HOPA). This year, the Association is asking that the residents furnish documentation such as a driver's license, birth certificate, etc. to provide proof of age and a copy of the declaration page of the Homeowner's HO6 policy. If there is a tenant in the unit, an HO4 declaration page of the policy is also required. This was part of the Resolution that was recently enacted by the Board that requires the residents to have an HO6 insurance policy on their unit and that the Association collect this data for the file. The Association is also asking that Residents update their information regarding Pets and provide a copy of the vaccination certificate annually. LVW Clubs are not permitted to post outside events on LVW property.

During the 2020 roofing season there was, as there is every year, a need for the repair or replacement of roofing substrate on some units that were being roofed. These unforeseen expenses are part of the roofing process, however, were not part of the approved 2020 roofing's \$537,248.25 expense voted on April 1, 2020. Moving forward we have made a forecasted estimate of these unforeseen expenses and have made them part of the 2021 approved roofing project. At this time, Management is requesting that the Board approve the additional substrate expenses of \$23,181.90 which was paid as part of the 2020 roofing project. This expense was provided by account #3270 – Capital Replacement/Roofs. The Board will vote on this at the next open Board meeting on May 5, 2021. As part of each year's roofing project there becomes a need to replace faulty skylights. A total of 18 skylights on nine units were replaced during this roofing process that now require post funding approval. In most cases the need for the replacement of these skylights cannot be determined until such time as the roof is being replaced. In order for a skylight to be replaced, it must first be inspected and approved by LVWA Management. Management is requesting that the Board approve the expense of \$15,775.00 for the replacement of 18 skylights. This expense will be provided by account #3270 – Capital Replacement/Roofs. The Board will vote on this at the next open Board meeting on May 5, 2021. Part of the approved Azek project is the replacement of the unit's gutter system with new 6" gutters and leaders. This year, 50 units with Azek and gutters were completed. These gutter replacements now require post funding approval. The average cost for gutters per Azek unit is \$661.00. At this time, Management is requesting that the Board approves the expense for the gutter replacements of the (50) 2020 Azek units completed for a cost of \$33,050.00. This expense will be provided by account #3270 – Capital Replacement/Roofs. The Board will vote on this at the next open Board meeting on May 5, 2021.

### UNFINISHED BUSINESS:

1. The Village will be opening the following amenities; Willow Golf Course, Tennis Courts, Pickleball Courts and the Farm on Monday May 3, 2021. The pools will open on May 28, 2021. The dog park will open, but the date will be announced. Reservations, signed waivers, and proof of vaccination will be required to use these amenities when opened. Waivers are available on LVWCreeper.com, the Association office, and Willow Hall. Failure to follow the guidelines set for the amenities will result in a fine of \$50.00, suspension of access card, suspension of transponder, or permit closure of amenity. No guests will be permitted to use the open amenities at this time.

2. Verizon has not provided a timeframe to remove the remaining pedestals in the Village. There has also been no resolution for the Rewards program. The Association Attorney will send a letter to Verizon with a deadline to respond.

3. Management is still working on the costs for the Encore Auditorium (flooring, doors, acoustic panels).

### NEW BUSINESS:

1. The 2021 Swimming Pool Rules were presented and reviewed. There was brief discussion clarifying the presented rules for gaining access and the timeframes to use the pools. W. Steinman moved to approve the 2021 Swimming Pool Rules. T. Hardman seconded.

J. Carmody asked that residents comply with the use of amenities in which they were designed for.

A.DAmato reminded residents that the dog park will open after it is spruced up and the date of the opening will be announced when completed.

The next open Board meeting is scheduled for Wednesday, May 5, 2021 at 1:00 PM via Zoom.

There being no further business, the Board meeting adjourned at approximately 1:56 PM.

Residents are reminded that the 5-foot area is their responsibility. Please keep the trees and shrubs trimmed to avoid any damage to the unit's roof or siding. Also, when using a ground cover against the foundation of your home, be sure the material used is away from the foundation by at least 4 inches.

A Permit is required for any alteration, modification, or planting.

1. Require a Permit Application before any alterations, modification, and planting to a unit is begun.
2. Fine any unit owner fifty dollars (\$50.00) for not obtaining a permit prior to installing improvements, modifications, or alterations to a unit.
3. If a permit is not applied for within ten days, a ten dollar (\$10.00) per day penalty will be assessed until a permit is applied for.
4. The imposition of this fine does not grant approval of a permit. If upon application for the respective permit, the permit is denied, the improvement, modification, or alteration will be restored to its prior condition at the sole expense of the unit owner.
5. A fine to restore or correct violation will be assessed according to the Resident Handbook's existing fine schedule or amended.
6. This will become effective and applicable to future modification upon approval.

**SPECIFICATION FOR LANDSCAPING IN THE FIVE-FOOT AREA BY RESIDENTS**

**THE 5-FOOT AREA IS THE ORIGINAL SPACE ABUTTING THE UNIT, ALLOCATED BY THE BUILDER AND ARCHITECT AS A PERMANENT LANDSCAPED AREA.**

**I. GENERAL RULES**

- A. Residents must maintain the five-foot area **predominantly** as a **planting area** and Must have foundation plantings. In addition, five-foot area may not have pavers or bricks as ground cover
- B. Planting of low-growing bushes, shrubs, flowers or ground cover is permitted in an area extending five (5) feet from the foundation of a unit and the area between unit walls and walkways. **NO TREES** may be planted in the-(5) foot area.
- C. The center of all bushes and shrubs must be at least thirty (30) inches from the unit foundation and all branches, etc., including ground cover, i.e. mulch, gravel, etc. must be kept maintained and/or trimmed to at least twelve (12) inches from the unit siding to minimize damage to siding.
- D. Planting in front of windows must be maintained to not exceed three (3) feet in height and preferably not higher than the windows. Plantings must not obstruct access to or from the window. Mature shrubs should be trimmed to leave the upper panes of windows unobstructed.
- E. Planting in front of solid walls must be maintained so as not to exceed five (5) feet in height and should be trimmed to a height where they do not brush against the siding or overhang gutters.
- F. In order to prevent damage from rot, insect damage and/or mold, the entire five-foot area must be kept **4 inches below** the bottom of any siding material, when possible. This includes the top of any groundcover, mulch, stones, gravel, edging material, etc., that are within the area. Edging material should not be higher than 6 inches above grade and parallel to the foundation/siding and must not block water drainage away from unit.
- G. The restrictions in the previous paragraph must apply where there is brick, stone, or any other masonry veneer. The lowest portion of any concealed framing behind the veneer must be determined by measurement.
- H. **Water shutoffs and sewer cleanouts must remain visible for emergency access.**
- I. **No furniture or structures are permitted in the five-foot area.**

## Happy Father's Day

Association@lvwa.net

I need to undo something I started. Let me explain in a long-winded way; Leisure Village West has a domain name on the internet, it's www.lvwa.net; in fact, we have several domains. For email, having a domain makes it easy to have multiple email addresses within a company or an association like ours. For email, we have a catch-all framework. A catch-all feature takes all email that comes to @lvwa.net (our domain) and sorts it using a defined set of rules and sends it off to the actual recipient. For our office, it will sort my email and send it off to me, Michelle, Sam, and so on for everyone in our office. If the catch-all finds an email address that doesn't match anyone's address at the office, it sends all of that undeliverable mail to what's called an Admin account, like spam. I try to keep an eye on that folder as I may see an email that may have some misspellings, but I may determine it was intended to go to someone here.

I don't know why I felt compelled to start with the catch-all rationalization, but I did. Why it's somewhat relevant, it was easy for me to create an email address for every unique item where we're looking for you to email the office on a particular subject. So, for waivers, HOPA, budgets, elections, and more, I created unique addresses for each. This complexity has led to confusion on where to send or reply to a request from the Association. So, to simplify and end some of the confusion, please start using the one email account for all submissions to the office at association@lvwa.net. The Board still maintains its email address, and I don't want you to be confused. If you have an issue you want to be directed to the Board, you may still contact them by emailing bot@lvwa.net

### **Patios, Five-Foot Areas, and Furniture**

Please note there is a distinct difference between a patio and your five-foot area. Patios are the places where typically furniture is placed for your enjoyment of the great outdoors. The five-foot area, on the other hand, is not a place to locate furniture. It may seem attractive to you as a decorative feature, but it gives others that it's permissible to have an additional place to relax. Moreover, it is not allowable as defined in specification 1\_1 and elsewhere within the Resident Handbook.

The Board, many years ago, granted the earliest models to have a patio, once prohibited by the developer. The decree leveled the playing field whereby every model of the community may have one patio. The original models must adhere to the specifications to add a patio, but once done, you may not add another, which is also true for the models designed with a patio. The Association sees these misplaced pieces of furniture as a second patio or an illegal patio if no permit is on file and doesn't conform to specifications.

So, if you're one of the few that have chairs, benches, or tables other than the ones permissible on your patio, please have them removed. We have instructed our inspectors to locate these infractions and report them to our office. Please strive to preserve the community's character keeping your five-foot area predominantly as a planting area with well-managed shrubs and flowers.

Please don't forget to do your spring cleanup while I have your attention on your five-foot area. Be sure to trim back shrubs 12 inches minimally from your siding and take action on any other overgrowth covering windows and walkways. Please weed the area to keep the village looking it's very best.

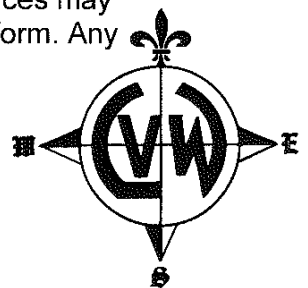

**Pools will be operating under the New Jersey COVID-19 Outdoor Pool Standards in addition to standards from the Association until further notice.**

- **Release, waiver, and indemnification agreement must be signed and submitted prior to being allowed entry.**
- **Access will be restricted to members only, no guests and no children.**
- **6-foot social distancing must be maintained while in the water and pool area except for immediate family members, caretakers, household members, or romantic partners.**
- **No chairs or tables will be provided; members may bring their own chairs but must take them away when leaving the pool area.**
- **No swimming aids will be provided. Members may bring their own approved swim aids; however, they may not be shared.**
- **Foot coverings are required within the restroom and shower area.**
- **Pool Managers/Covid Ambassadors will oversee the pool regulations.**

### **A Specially Exempt Facility** **No lifeguard on duty** **No swimming alone**

Pools open **Friday, May 28th** and are scheduled to close on **September 7<sup>th</sup>**.

**ENTRY:** Members must swipe their photo ID badge for verification of member status at the pool gate in order to obtain admittance to the pool area.

**ATTIRE:** Proper swim attire must be worn from home to pool since the changing area is limited. Cut-off jeans are not allowed in the pool. A cover-up wrap is needed when entering the clubhouses. The Association is not

responsible for any discoloration of bathing suits due to pool chemicals. Street shoes are not allowed in the pool. DO NOT LEAVE SHOES OR SLIPPERS AT THE POOL STEPS.

**DIAPERS:** Only diapers specially designed for immersion in water are permitted.

**SAFETY:** NO DIVING OR JUMPING IS ALLOWED AT EITHER POOL AND WILL BE STRICTLY ENFORCED. NO SITTING OR STANDING ON POOL STEPS UNLESS WHERE INDICATED AT THE *ENCORE POOL*. *Weather-related closures are at the discretion of the – CPO (Certified Pool Operator). The CPO will determine when to reopen the pool. CPO shall remain on duty during rain.*

**SWIM AIDS:** Noodles are not to exceed two per person. Swim aids which include noodles, are to be provided by the resident and may not be shared. Mesh seat noodles are also acceptable. Residents are permitted to use therapeutic aquatic belts.

**HEALTH:** **PERSONS WITH OPEN WOUNDS ARE NOT PERMITTED IN EITHER POOL OR JACUZZI AT ANY TIME. CPO WILL ENFORCE THIS RULE. Anyone with a temperature or flu-like symptoms will not be permitted entry.**

**FOOD:** Food and beverages are permitted in the pool area. NO GLASS OR OTHER SIMILAR CONTAINERS THAT MIGHT CAUSE PERSONAL INJURIES IF BROKEN ARE PERMITTED IN THE POOL AREAS. **NO ALCOHOLIC BEVERAGES ARE PERMITTED IN THE POOL AREAS.**

**SMOKING:** Neither smoking nor vaping are permitted within 25ft of the pool area. Please use designated areas.

**CHAIRS/LOUNGES:** Bring your own. Only one per resident. Must be removed when leaving.

**SHOWERS:** Bathers are required to shower before entering the pools. If water shoes are worn, please rinse before entering the pool.

**JACUZZI:** Residents are to read and follow the rules posted at the Jacuzzi.

**MUSIC:** Please use headphones where possible, otherwise be considerate, and keep the volume down as not to disturb fellow members.

# D-Day Landings: June 6, 1944



During World War II (1939-1945), the Battle of Normandy, which lasted from June 1944 to August 1944, resulted in the Allied liberation of Western Europe from Nazi Germany's control. Codenamed Operation Overlord, the battle began on June 6, 1944, also known as D-Day, when some 156,000 American, British and Canadian forces landed on five beaches along a 50-mile stretch of the heavily fortified coast of France's Normandy region. The invasion was one of the largest amphibious military assaults in history and required extensive planning. Prior to D-Day, the Allies conducted a large-scale deception campaign designed to mislead the Germans about the intended invasion target. By late August 1944, all of northern France had been liberated, and by the following spring the Allies had defeated the Germans. The Normandy landings have been called the beginning of the end of war in Europe.

Eisenhower gave the go-ahead for Operation Overlord. He told the troops: "You are about to embark upon the Great Crusade, toward which we have striven these many months. The eyes of the world are upon you." Later that day, more than 5,000 ships and landing craft carrying troops and supplies left England for the trip across the Channel to France, while more than 11,000 aircraft were mobilized to provide air cover and support for the invasion. By dawn on June 6, thousands of paratroopers and glider troops were already on the ground behind enemy lines, securing bridges and exit roads. The amphibious invasions began at 6:30 a.m. The British and Canadians overcame light opposition to capture beaches codenamed Gold, Juno and Sword, as did the Americans at Utah Beach. U.S. forces faced heavy resistance at Omaha Beach, where there were over 2,000 American casualties. However, by day's end, approximately 156,000 Allied troops had successfully stormed Normandy's beaches. According to some estimates, more than 4,000 Allied troops lost their lives in the D-Day invasion, with thousands more wounded or missing.

Less than a week later, on June 11, the beaches were fully secured and over 326,000 troops, more than 50,000 vehicles and some 100,000 tons of equipment had landed at Normandy.

The Normandy invasion began to turn the tide against the Nazis. A significant psychological blow, it also prevented Hitler from sending troops from France to build up his Eastern Front against the advancing Soviets. The following spring, on May 8, 1945, the Allies formally accepted the unconditional surrender of Nazi Germany. Hitler had committed suicide a week earlier, on April 30.

### **Stress-less Gardening Tips**

- Stretch before and AFTER your yard work.
- Choose low maintenance plants such as groundcovers and perennials instead of annuals.
- Use raised beds to reduce bending.
- Buy garden supplies in small, lightweight quantities.
- Take frequent breaks and rotate between jobs so that the back or knees are not strained for long periods of time. STRETCH frequently.
- Be conscious of the twisting motion – use proper body mechanics.

### **Be healthy and safe in the garden**

Dress to protect – Use sunscreen SPF 15 or higher and both UVA and UVB protection. Wear light-colored clothing. Always check your clothes and body for ticks.

Remember, the hours between 10 a.m. and 4 p.m. are the most hazardous for UV exposure. Wear a hat with a wide rim to shade the face, head, ears, and neck.

Know your limits in the heat.

Monitor your activities and time in the sun to lower your risk for heat-related illness.

Stay hydrated.

Avoid beverages with alcohol and drinks high in sugar; stay away from caffeinated and carbonated beverages. Have water handy to decrease the chance of dehydration.

# WHERE TO SEE FAMOUS AMERICAN FLAGS



There is no greater symbol of American pride than its iconic red, white and blue flag. Since our country was founded in 1776, the U.S. flag undergone 27 changes: some of its alterations have been subtle and others were more dramatic. But no matter which flag has been flown, each one has represented the concept of freedom, justice and prosperity for all. The Stars and Stripes have been flown during our country's most memorable events, including battles, inaugurations, parades, state funerals and national holidays, just to name a few.

Here are some of our country's most famous flags and where you can see them:

## **Betsy Ross Flag.**

**Where:** The Betsy Ross House; 239 Arch Street., Philadelphia

**The story:** During the Revolutionary War, a seamstress named Betsy Ross was credited with stitching together the first American flag. Although there is no conclusive evidence to substantiate that claim, Ross did make several flags for the Pennsylvania navy. The original Betsy Ross Flag no longer exists but you can see a replica at the Betsy Ross House in Philadelphia, Pa. This landmark also offers educational programs for the entire family and serves as headquarters for Philadelphia's Flag Day celebrations.

## **The Star Spangled Banner.**

**Where:** National Museum of American History; Constitutional Ave., NW between 12th and 14th Streets, Washington D.C.

The story: Widely recognized as America's most beloved flag, the Star Spangled Banner flew over Fort McHenry during a 25-hour siege by British forces, from September 13 to 14, 1814. Francis Scott Key was so overjoyed to see this 30' by 42' garrison flag still standing that he was inspired to write our national anthem—"The Star Spangled Banner." Now

housed at the National Museum of American History in Washington, D.C., The Star Spangled Banner is stored in a climate-controlled case to prevent the flag from suffering further deterioration.

## **Old Glory.**

**Where:** National Museum of American History; Constitutional Ave., NW between 12th and 14th Streets, Washington D.C.

The story: One of our country's most iconic flags, Old Glory is a 10' by 17' 24-star flag that belonged to William Driver, a captain and master mariner from Salem, Mass. Driver took Old Glory with him on several sea adventures around the world and he later hoisted the flag over Tennessee's capitol building when Union forces captured Nashville during the Civil War. Old Glory is so famous that it has become a nickname for other U.S. flags. Today, Old Glory is on display at The National Museum of American History in Washington, D.C.

## **Iwo Jima Flags.**

**Where:** National Museum of Marine Corps, 18900 Jefferson Davis Hwy., Triangle, VA

The story: As the Battle of Iwo Jima raged on, Associated Press photographer Joe Rosenthal heard that a group of U.S. Marines had just secured Mt. Suribachi and planted an American flag on the summit. Rosenthal arrived at the scene in time to take pictures of another group of Marines who were hoisting an even larger flag atop Mt. Suribachi. Rosenthal won a Pulitzer Prize for his iconic photo and the picture helped inspire America's troops turn the tide to win the Second World War. Today, both Iwo Jima Flags have been preserved as artifacts at the National Museum of the Marine Corps.

## **Six Apollo Flags.**

**Where:** National Air & Space Museum; Independence Ave. at 6th st., SW Washington D.C.

The story: Who can forget the grainy image of

astronaut Neil Armstrong planting the U.S. flag on the barren lunar landscape? Altogether, six Apollo flags were left on the moon by American astronauts between 1969 and 1972. Ordered from a government supply catalog, each nylon flag measured about 3' by 5.' There is speculation that the flags may have been bleached white by intense ultraviolet radiation or disintegrated from the heat generated by takeoff rockets. If you're lucky to catch a SpaceX flight to the moon, you may be able to take a selfie next to one of the Apollo flags. Otherwise, be sure to see a replica at the National Air and Space Museum in Washington, D.C.

## 9/11 Flag.

**Where:** National Sept. 11 Memorial & Museum, 180 Greenwich St, New York, NY 10007

The story: Following the September 11 attacks in 2001, three New York City firefighters who were on the scene hoisted a 4' by 6' flag above the ruins of the World Trade Center. They discovered the flag on a yacht belonging to Shirley Dreifus and her late husband Spiros E. Kopelakis. Thomas E. Franklin, a photojournalist who happened to be at Ground Zero following the collapse of the twin towers, immortalized America's spirit of resilience by snapping pictures of the historic flag raising. A few hours later the flag vanished and was missing until it was discovered 15 years later in Everett, Wash. The 911 flag is now on display at the National Sept. 11 Memorial & Museum in lower Manhattan.

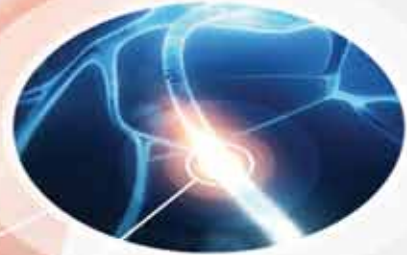

## **Flag Code**

- ➔ The American flag may be displayed on a flagstaff (pole for attaching the flag) during daylight hours and at night if lights are shown on it.
- ➔ The American flag should be displayed near schools, government buildings, public buildings, and polling (voting) places.
- ➔ When flown with other flags, the American flag should have the place of honor (either higher than the other flags or to its own right).
- ➔ The American flag should be the first flag to be raised and the last flag to be lowered.
- ➔ When displayed in a church or on a stage, the American flag should be displayed in the position of honor either behind and above the speaker or at the speaker's right as he or she faces the audience.
- ➔ When displayed without a flagstaff, the field of stars of the American flag should be on the upper left.
- ➔ When the American flag is carried at the beginning of a parade, spectators (people watching) should remove hats and stand at attention with the right hand placed over the heart. This salute should be held until the American flag has passed.
- ➔ The President or Governor may order the American flag to be flown at half-staff (halfway between the top and bottom of the flag pole) to pay respect to someone (usually a government leader) who has died.
- ➔ The American flag is used to cover the casket of a person who has served in the military. It is removed before the casket is lowered into the grave.
- ➔ Folding the American flag properly is done by two people following strict guidelines used only for this flag.
- ➔ The American flag should not be allowed to touch the ground.
- ➔ The American flag should not be displayed during stormy weather unless an all-weather flag is used.
- ➔ The American flag should not be draped to hang over any part of a vehicle, train, or boat.
- ➔ The American flag should not be used as clothing, bedding, or drapery.
- ➔ The American flag should not be used for decorating or advertising.
- ➔ The American flag should not have anything attached to it or printed on it.
- ➔ The American flag should not be displayed if it is worn or frayed. It should be disposed of in a respectful manner.



## The History of Father's Day

Like *Mother's Day*, the modern American version of Father's Day has a history that goes well beyond greeting cards.

The first known Father's Day service occurred in Fairmont, West Virginia, on July 5, 1908, after hundreds of men died in the worst mining accident in U.S. history. The Sunday service happened because of the efforts of Grace Golden Clayton, the daughter of a dedicated reverend.

While missing her own dad, who had died in 1896, Mrs. Clayton wanted to honor the many fathers who had died in the mining explosion, which killed more than 360 men and boys and left about 1,000 children fatherless. Although the Fairmont service was the first known to honor fathers, it did not turn into an annual event, nor was the idea promoted (a large July 4 celebration in Fairmont and a tragic young death from typhoid fever took over the news at the time).

### Father's Day Gains Momentum

Several other people across the nation had similar ideas throughout the years, but Mrs. Sonora Smart Dodd is credited for being the one to popularize it, starting events that led to Father's Day becoming a U.S. national holiday.

Her story began as she sat listening to a Mother's Day sermon in 1909. Mrs. Dodd thought that it might be nice to honor fathers as well. Her father, William Smart, had raised his SIX children alone on his farm in Washington after his wife died giving birth.

Mrs. Dodd proposed to the Spokane Ministerial Association and the YMCA that they celebrate a "father's day." She chose the 5th of June because it was her father's birthday.

The idea received strong support, but the good ministers of Spokane asked that the day be changed to give them extra time to prepare sermons on the unexplored subject of fathers. The first Father's Day in Spokane, Washington, was observed on June 19, 1910 (the third Sunday in June) and became an annual event there. Soon, other towns had their own celebrations.

### From Local Celebration to National Holiday

In spite of widespread support, Father's Day did not become a permanent national holiday for many years. The first bill was introduced in Congress in 1913, but despite encouragement by President Woodrow Wilson, it did not pass. In 1966, Lyndon Johnson issued a proclamation designating the third Sunday in June to honor fathers.

Finally, in 1972, President Richard Nixon signed a law declaring that Father's Day be celebrated annually on the third Sunday in June. It has been an official, permanent national holiday ever since.

Farmer's Almanac



Simply put, Juneteenth is “the oldest nationally celebrated commemoration of the ending of slavery in the United States.”

In addition to marking a date of major significance in American history, Juneteenth has always been both a day of remembrance and an opportunity for African-Americans to honor their history and celebrate Black culture.

African-American historian and Harvard professor Henry Louis Gates, Jr. writes that, over generations, Juneteenth became: “an occasion for gathering lost family members, measuring progress against freedom and inculcating rising generations with the values of self-improvement and racial uplift. This was accomplished through readings of the Emancipation Proclamation, religious sermons and spirituals, the preservation of slave food delicacies (always at the center: the almighty barbecue pit), as well as the incorporation of new games and traditions, from baseball to rodeos and, later, stock car races and overhead flights.”

In 1866, freed slaves in Texas marked June 19 with anniversary celebrations that included prayer services and church gatherings in the Black community.

Over subsequent years, former slaves and their families continued celebrating their freedom with annual Juneteenth celebrations that featured former slaves delivering inspirational speeches and reading from the Emancipation Proclamation. It marked a day for “grass-roots celebration highlighted by joyous singing, pig roasts, and rodeos.”

June's full moon, known as the **Strawberry Moon**, will reach peak illumination at 3:12 P.M. Eastern Time on the 5th but will not be visible until later that evening.

### **A Penumbral Eclipse**

This full Moon brings with it a **penumbral eclipse**, which occurs when the Moon crosses through the faint outer edge of Earth's shadow (the penumbra), making part of the Moon appear ever-so-slightly darker than usual. Unlike a full lunar or solar eclipse, the visual effect of a penumbral eclipse is usually so minimal that it can be difficult to perceive at all!

### **WHY IS IT CALLED THE FULL STRAWBERRY MOON?**

June's full Moon—typically the last full Moon of spring or the first of summer—is traditionally called the **Strawberry Moon**.

The tradition of naming Moons is rich in history. *The Old Farmer's Almanac* has long honored the Native American Moon names and the folklore of those who came before us. We follow the full Moon names that were used during Native American and Colonial times to help track the seasons—usually from the Algonquin tribes who lived in the same areas as the Colonists.

The name, Strawberry Moon, originated with Algonquin tribes in eastern North America who knew it as a signal to gather the ripening fruit of wild strawberries. Alternative European names for this Moon include the **Honey Moon** and the **Mead Moon**. It has also been called the **Rose Moon**, given that many roses come to life during this part of the year!

**Did You Know:** June was traditionally the month of marriages and is even named after the Roman goddess of marriage, Juno. Following marriage comes the “honeymoon,” which may be tied to this full Moon's name!

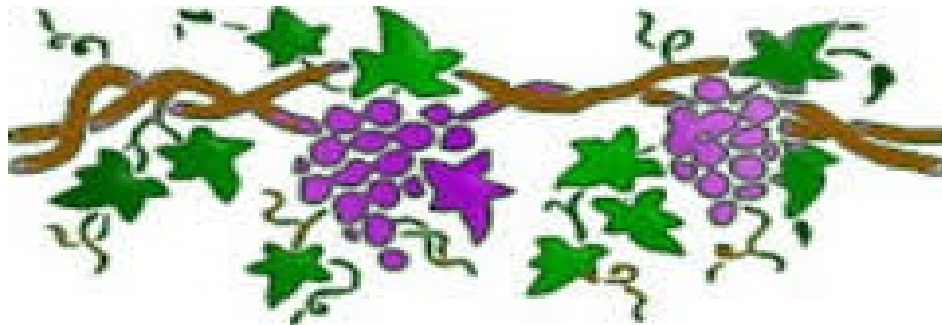

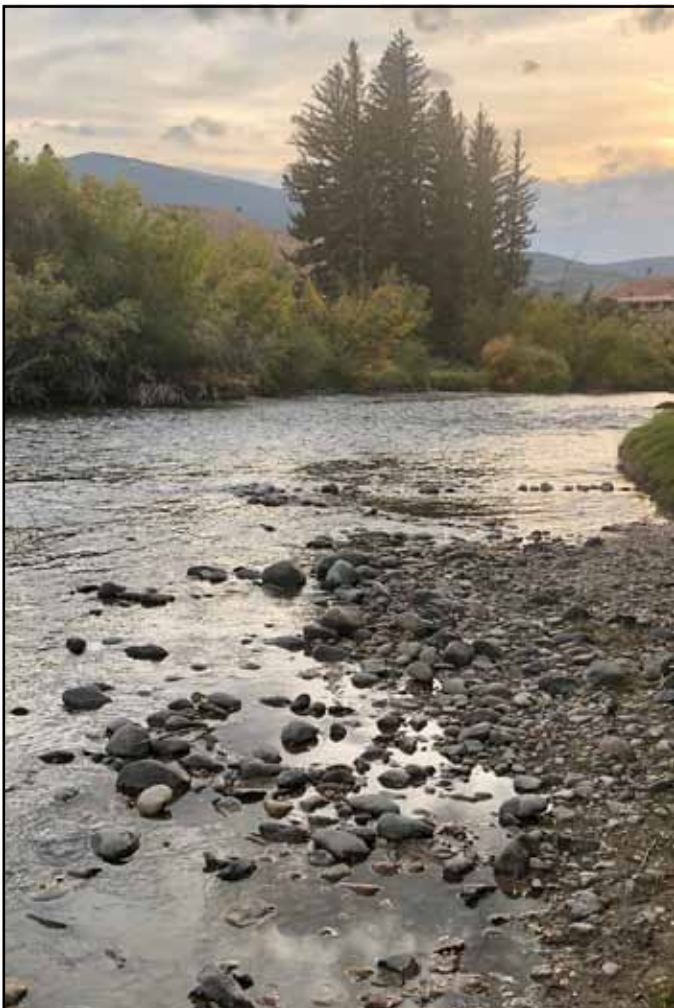

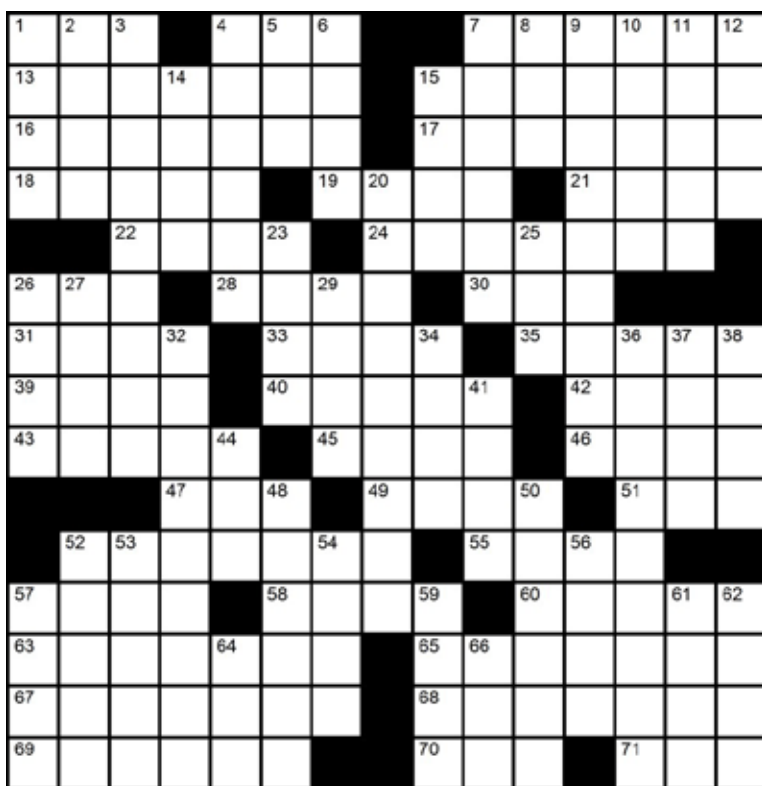
Studies have shown that walking each week for three hours reduces the risks of developing certain types of cancers. Getting some fresh air never sounded so good.

It's a busy time, not just for bees, and the natural world in summer is a fabulous feast for the senses. The days are long and the nights short.

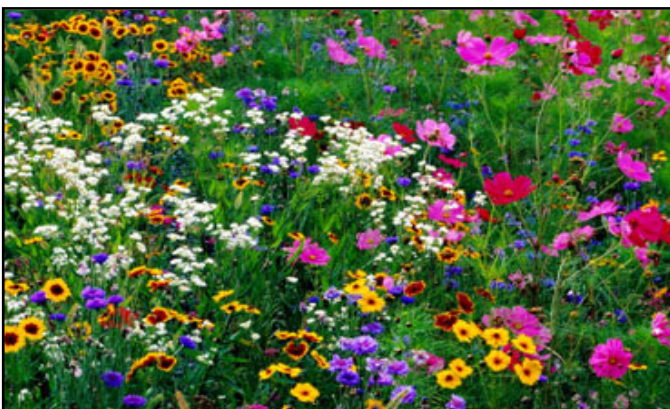

When the sun is shining, it is impossible not to smile as a beautiful butterfly flitters past or a bumblebee blunders from flower to flower.

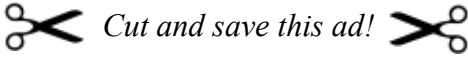

## Looking Good

You can “tie me kangaroo down, mate,” but, chances are, he’ll still be following your every move!

As published in *Biology Letters*, the University of Roehampton and the University of Sydney collaborated in a study involving wild (habituated but not domesticated) kangaroos. Conducted at three locations in Australia, the study demonstrated how purposefully the selected kangaroos stared at the persons implementing the trial as they placed some of the ‘roos’ favorite foods in a closed box. Presenting the kangaroos with a known food source they could not access defined the experiment’s “unsolvable task.” Instead of investigating and vigorously trying to open the box on their own, they conveyed their desire for the hidden food through a series of ardent gazes directed at the human participants, willing them to open the box post haste. Ten of the 11 kangaroos gazed fixedly at the individual who placed the food in the box; nine of the 11 toggled their attention between the human and the box,



clearly reinforcing their intent. Such enhanced modes of communication customarily occur with domestic animals, where interaction with humans is a daily event. But wild kangaroos attempting to mesmerize humans into compliance is deemed something of a novelty!

In an unrelated study conducted by the University of Exeter, Herring Gulls were observed to react in specific and predictable ways when being watched by humans. As related in the journal *Animal Behaviour*, the subject gulls ambled away at their own measured pace when closely approached by persons who were not paying particular attention to the

birds. However, when the researchers pointedly stared at the gulls, the birds walked or flew away with much greater alacrity. Newly fledged gulls demonstrated the same appropriate response, indicating they were born with this instinct or were quickly taught the exigent need to flee by their parents. Both adult and juvenile birds concentrated on the eye movements of each researcher, effectively refining their capacity for threat assessment.

The cohort consisted of 155 gulls. Fifty adults and 45 juveniles were from urban settings, while 34 adults and 26 juveniles came from rural environs. Unsurprisingly, the city gulls appeared to be of sterner stuff, allowing the researchers to approach within 2.5 meters (about 8 feet) closer before skedaddling. Less inured to humans the country gulls were much more reactive, being three times more likely to fly, instead of just walk, away.

So, as conveyed by kangaroos and gulls in their own unique fashion, “here’s looking at you, kid.”
