- S. Nordell moved to approve the Association to contract with Traffic Lines Inc. to restripe 15,232 feet of thermoplastic lines for Thornbury Lane and Huntington Drive at a total cost of \$10,301.48. Willow Sound System / Wireless microphone system

I have been asked to research the costs of a wireless microphone system for the Willow Hall Sound system. I have consulted with professional sound installation companies. I have contacted the Shure Microphones Incorporated and their authorized dealers, and I have met with residents who use the facility. Based on my research I am recommending the Shure QLX-D wireless system as quoted below:

It is my recommendation to purchase the Shure QLX-D systems from Northern Sound & Light. The total cost is \$16,005.27. This expense will be charged to GL# 3150 - Property Fund – Replacements.



LEISURE VILLAGE WEST PROPOSED BYLAWS & MASTER DEED AMENDMENT

Amend the LVW "Bylaws", Article III, Section 10 to state:

"All decisions of the members including capital expenditures, other than the expenditure of the Association funds the purposes set forth in Schedule A annexed hereto, shall require for passage, affirmative vote of the members representing at least 80 percent (PROPOSED CHANGE TO 55%) in interest of the undivided ownership of the Condominiums as a whole. The Trustees shall be governed in the making of capital expenditures, other than expenditures made for the purposes set forth in Schedule A annexed hereto, and in other actions by decision made by the members as provided in this section. All other decisions shall require for passage, the affirmative vote of at least a majority of the members in good standing and entitled to vote.

Amend the "Amended and Consolidated Master Deed and Declaration of Restrictive and Protective Covenants", Section 17 to state:

LEISURE VILLAGE WEST ASSOCIATION may acquire recreational facilities whether or not contiguous to the Condominium property for the enjoyment, recreation and benefit of Unit owners. Such recreational facilities may consist of a community hall or auditorium, arts and crafts rooms, card rooms, meeting rooms, woodworking shop, swimming pool, pool building, lakes or ponds, golf courses, shuffleboards, etc., and the fees, costs and expenses of acquiring, maintaining, operating, repairing or replacing any of such facilities and the personal property used in the operation of enjoyment of the same, shall be common expenses. The purchase or acquisition for value of additional recreational facilities with funds of LEISURE VILLAGE WEST ASSOCIATION shall be deemed to be a capital expense and thus require authorization by an affirmative vote of 80 percent (PROPOSED CHANGE TO 55%) of the interest of the members representative of the undivided ownership of the Condominium as a whole, notwithstanding anything to the contrary in the Bylaws.
