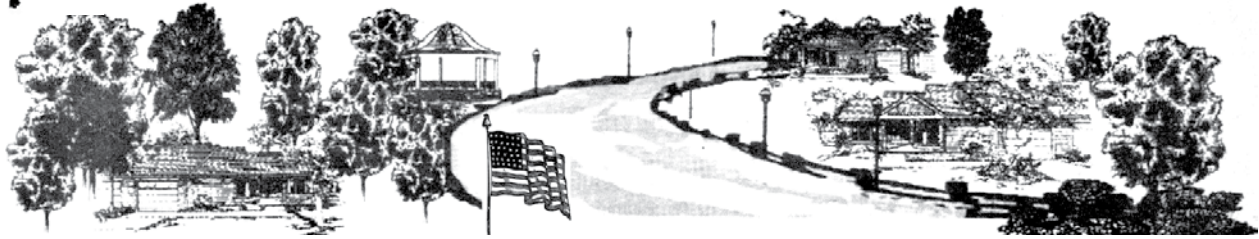

### Leisure Village West Association

## Board of Trustees Meeting – July 6, 2016

Present were Sue Nordell, Louis Maiocco, Russ Steenweg, Sandra Kaufman, Marge King and Charles Lupo. Also present were Community Manager Joseph Schultz, Accounting Administrator Michelle Lampard and Recreation Director Mary Lighthipe. Sal Tozzi was absent.

The meeting commenced at approximately 1 p.m. with the Pledge of Allegiance.

S. Kaufman informed resident's that Sidney Derner, a former trustee, passed away on July 3 and will be missed.

C. Lupo made a motion to review the June 1, 2016 and approve the June 15, 2016 minutes. R. Steenweg seconded. All in favor. S. Tozzi absent. Motion carried.

S. Nordell made a motion to approve Frances Siddons and Gloria Kealy to the Administration Division. R. Steenweg seconded. All in favor. S. Tozzi absent. Motion carried.

M. King made a motion to approve Margaret Kavazanjian to the Election Committee. S. Nordell seconded. All in favor. S. Tozzi absent. Motion carried.

R. Steenweg made a motion to memorialize the purchase of a Cecilware FE200 Urn from Webstaurant Store at a cost of \$3,062.45 including shipping and sales tax. The funds to meet this expense were provided by account #3150 – Property Fund – Equipment Replacement. S. Nordell seconded. All in favor. S. Tozzi absent. Motion carried.

L. Maiocco made a motion to memorialize the purchase of one True Fitness CS - 600 from Gym Source at a cost not to exceed \$5,022.88 including tax, setup

and delivery. The funds to meet this expense were provided by account #3150 – Property Fund – Equipment Replacement. C. Lupo seconded. All in favor. S. Tozzi absent. Motion carried.

C. Lupo made a motion to authorize the Association to replace four existing gates with aluminum vertical pivot gates from Sun Power Security Gates for a total cost of \$40,129.30 including tax and shipping. The funds to meet this expense will be provided by account #3150 – Property Fund – Equipment Replacement. S. Nordell seconded. All in favor. S. Tozzi absent. Motion carried.

S. Nordell made a motion to authorize the Association to enter into a lease agreement with Clearview Capital and installation by Solis Partners for the Solar Panels on the maintenance buildings. R. Steenweg seconded. All in favor. S. Tozzi absent. Motion carried.

R. Steenweg made a motion to authorize the Association to contract with Carl's Fencing for the purchase and installation of 3,139 sections of vinyl fencing at a cost of \$437,960.06. The funds to meet this expense will be provided by account #3000 – Deferred Maintenance. C. Lupo seconded. L. Maiocco, Yes; C. Lupo, Yes; M. King, No; S. Nordell, Yes; R. Steenweg, Yes; S. Tozzi, Absent; S. Kaufman, Yes. Motion carried.

M. King made a motion to authorize the Association to go out to vote to amend the Bylaws relating to Fee Shifting. S. Nordell seconded. All in favor. S. Tozzi absent. Motion carried.

### Manager's Report

J. Schultz stated that High Definition cameras are being installed and the first one being used is by the recycling container. He also reminded residents that this container should be used only for recycling newspapers and household items are prohibited.

He clarified a message that was placed on the television creeper regarding lids for residents recycling containers. He stated it is recommended by the Association to secure your recyclables to prevent the items from blowing in the street.

He also spoke about the children pool hours and asked that when the children hours end at the pool for residents to allow them sometime to evacuate the pool area.

He mentioned paving will commence on Monday, July 11 in the Thornbury area. A one-call will be placed to notify all residents that paving will take place in the village. He also mentioned this could take between 4 to 5 days to complete.

### Recreation Report

M. Lighthipe mentioned Bingo games are tonight. The doors open at 6:15 p.m. and the games begin at 7 p.m. She also mentioned tickets will be available for the Sunday dinner trip to the Brickhouse Restaurant on July 10. She was pleased to announce the village bus service to the concerts at the Harry Wright Lake. The concert dates include July 13 and August 10 and 24. Departure for the Bluegrass and Blueberry Festival at Peddler's Village is on Sunday, July 17. She also stated a baseball game between the NY Yankees and the Baltimore Orioles will be on July 21 and tickets include bus, game, admission and gratuity.

### Old Business

The board is still waiting to hear from the attorney who will provide the language for the Door to Door policy.

J. Schultz mentioned the Association has received 1,143 ballots so far and if residents have not voted to please send their ballots in as soon as possible. He also mentioned as a reminder, a meeting will be held on July 20 at 7 p.m. for residents that need to address any concerns regarding the Bylaws amendment relating to leasing fees.

J. Schultz informed residents the board has not reached a decision yet regarding a new cable provider. He asked residents if they have any comments to help the board finalize this decision they can do so via e-mail.

S. Nordell stated that she researched a comment that was made at the last meeting regarding the black plague in chipmunks. She called the NJ Department of Wildlife who referred her to the Ocean County Health Department. They assured her that there has been no type of a plague on the East coast associated with chipmunks. She visited the CDC website where it states it's in the western U.S.

### Audience Comments

J. Ercolino spoke about the Reserves with respect to the fencing project.

F. Siddons thanked J. Langriech and all the members of the Administration division for their recommendation and the board for their approval.

P. Burke thanked the board for extending the pool hours at the Willow pool and suggested the hours be extended at the Encore pool.

E. Baumeister expressed that she is neutral on the vinyl fence project and asked if the bylaws can be looked at for clarification.

C. Nocera spoke about the cleaning of the pools and the music being played by residents in the pool area.

M. Lamberti spoke about the Master deed referencing fences.

S. Cervino addressed her concerns regarding a unit.

B. Dunn agreed with the previous residents comment.

There being nothing further to discuss, this meeting ended at approximately 2:47 p.m.

## Visitors Lists, Contact Numbers and More

This is a great time to check your visitors list and bring it up to date along with your contact numbers. On Saturday, June 4, seven veterans left Club Encore at 4:30 a.m. for Washington, D.C. Hal Kravetz solicited and arranged for them to obtain applications needed to go on this trip. # Brain Benefits of Yoga

We've heard about the physical benefits of yoga. It helps us stay flexible, strengthens the body, improves posture and balance and facilitates healing, reasons enough to do it.

But some of the best benefits happen 'under the hood.' Movement coordinated with breathing soothes the nervous system, lowers blood pressure and heart rate and reduces stress. Yoga increases serotonin, which improves appetite control and sleep patterns. Yoga also reduces cortisol, lowering inflammation. This has major implications for heart disease and diabetes.

Yoga has been shown to improve mood. It acts like an antidepressant, which is good news for folks with depression, anxiety, sleep disorders, PTSD, ADHD and schizophrenia.

A recent study found that yoga could aid with memory and cognition, too. Twenty-nine middle-aged and older people, who tested positive for mild cognitive impairment, were divided into two groups. One group did brain-training one hour a week, with a home practice of 15 minutes a day. The other group did Kundalini Yoga one hour a week and a home

practice of mantra meditation with hand movements for 15 minutes a day.

After 12 weeks, both groups were retested. All improved, but the yoga group fared slightly better on the memory tests and also gained improvements in mood, plus a greater ability to focus and multitask.

In another study, 20 minutes of Hatha (physical) yoga was compared to 20 minutes of jogging. The yoga improved brain speed and accuracy to a greater degree than the jogging.

Lest we forget, the original purpose of yoga was to stretch out the body so monks could sit still in meditation, leading to enlightenment.

Beginners are more than welcome. You will need comfortable, unrestricting clothing and a yoga mat. Some also bring water bottles. If you've ever wondered if yoga is for you, why not give it a try? We'd be happy to have you join us.

# Heritage Mineral Plans Continue to Evolve

From the Desk of Mayor Kenneth T. Palmer

As you know, Manchester Township has been exploring development alternatives on the Heritage Mineral Tract. Recently, the Township Council passed Ordinance 16-022, approving a Redevelopment Plan that conceptualized a "Town Center" project. I supported the Council's decision to approve the concept because I believe the manner in which the Heritage Minerals Tract is developed is the single most important issue affecting Manchester Township's economic future. However, as I have repeatedly and publicly stated, neither I nor the Town Council were in favor of 6,543 units. That much development would never be in Manchester's best interests. We agreed to the Redevelopment Plan in order to start the process of vetting out a possible plan that was "right" for Manchester Township.

As promised, since the Council's approval of the Redevelopment Plan, we have sought input from the Department of Environmental Protection (DEP). They have indicated development beyond the 2004 settlement agreement's 1,000 acre "footprint" would be extremely difficult given the various environmental issues, permit requirements and effects on threatened

and endangered species. Hearing the DEP's concerns and those of our residents, I, along with the Town Council, have decided to withdraw the plan. As such, earlier this morning I vetoed Ordinance 16-022.

Please note, we still believe Manchester needs to re-consider the 2004 settlement agreement and the manner in which the Heritage Minerals Tract is developed. Currently, pursuant to the 2004 settlement agreement, Hovsons can develop a senior community of 2,400 homes without any input from the township (aside from the customary Planning Board approvals). While such a development would financially help the township in the short term, adding that many senior homes could realistically further tilt the state school funding formula against Manchester to becoming a 'No-Aid' district. While we only receive 14 percent of our school budget from the State, it does amount to approximately 8 million dollars. Therefore, I, along with the Council, will continue to explore concepts with Hovsons that will not affect the 2004 settlement "footprint" but does work in Manchester Township's best interests.

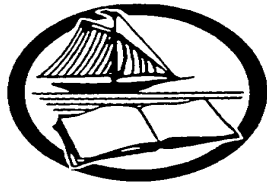

Manchester Township Water Utility Eastern Service District Customers  
**Mandatory Lawn and Landscape Watering Restrictions Continues**

Continuing drought conditions and customer demands for water due to lawn irrigation force the Township to continue the mandatory water restrictions that were placed in effect June 28. Reducing water use during peak periods is essential to our provision of an uninterrupted supply of water, particularly in emergencies, such as fires. The following mandatory lawn and landscape watering restrictions are continued in our Eastern Service District until further notice.

1. Watering shall be defined as the sprinkling, watering or irrigation of shrubbery, trees, lawns, grass, ground covers, plants, vines, gardens, vegetables, flowers, or any vegetation.
2. Properties with odd numbered street addresses may water only on odd calendar dates (such as June 29) except for the 31<sup>st</sup> of a month on which watering is prohibited.
3. Properties with even numbered street addresses may water only on even calendar dates (such as June 28).
4. Watering is not permitted between the hours of 10 a.m. and 5 p.m.
5. Watering of any single area shall not exceed 30 minutes in a day.
6. These restrictions shall apply to all residential and commercial properties served by Manchester Township that are located in the Water Utility's Eastern Service District except for public parks, public recreation areas and nurseries. Hanging plants are exempt. Any newly seeded or sodded lawn areas for up to thirty days after initial seeding or sodding are also exempt provided there is a small sign visible from the street in the front yard indicating "new seed" or "new sod" and the date of installation.
7. These restrictions shall not apply to residents and commercial properties which are served by other water utility companies or which obtain their potable water from their own private well.
8. These restrictions shall not apply to customers that obtain water for lawn and landscape watering from their own private well provided they place a small sign visible from the street in their front yard indicating "Private Well."
9. Violators of these restrictions are subject to fines. These regulations will be enforced by any authorized employee of the Department of Public Works, Code Enforcement officers, and any member of the Police Department who shall observe any person using or withdrawing water in violation of these restrictions.

Thank you for your anticipated compliance with these water conservation measures.

Lap Lanes	Residents must yield to lap lane swimmers at the Encore Pool
Adult Guests	<b>(Accompanied by a resident)</b> Regular pool hours as listed above.
Youth Guests	4 to 14 years of age <b>(Accompanied by a resident)</b> 10 am to 1 p.m. at Encore Pool & Pool Area 4 to 7 p.m. at Willow Pool & Pool Area

**Youth guests under 4 years of age are not permitted in either pool.** Youth guests with diapers are **NOT PERMITTED** in the pool. In the event of the closing of one pool; the youth guest hours are as follows at the opened pool – 11 a.m. to 1 p.m. and 4 to 7 p.m.

<b>BADGES:</b>	Residents and guests <b>MUST PRESENT APPROPRIATE BADGES</b> ; those not presenting the proper badges will be denied entry into the pool area. Residents are to present their <b>RESIDENT BADGE (Name)</b> for entry into the pool. <b>ALL</b> guests including youth guests of residents are to present <b>GUEST BADGES (Street Address)</b> for entry into the pool.
<b>ATTIRE:</b>	Proper swim attire must be worn from home to pool since changing area is limited. Cut-off jeans are not allowed in the pool. <b>DIAPERS (ADULT/CHILD) ARE NOT PERMITTED IN THE POOL.</b> A cover-up wrap is needed when coming to and from the pool or when outside the pool area. The Association is not responsible for any discoloration of bathing suits due to pool chemicals. Street shoes are not allowed in the pool. <b>DO NOT LEAVE SHOES OR SLIPPERS AT THE POOL STEPS.</b>
<b>SAFETY:</b>	<b>NO DIVING OR JUMPING IS ALLOWED AT EITHER POOL AND WILL BE STRICTLY ENFORCED. NO SITTING OR STANDING ON POOL STEPS. RESIDENTS &amp; GUESTS MAY SIT ON STEPS WHERE INDICATED AT THE ENCORE POOL.</b>
<b>SWIM AIDS:</b>	<b>NO</b> swim aids, floats, toy surfboards or swim toys are permitted in the pool with the exception of noodles. <b>One noodle per person will be permitted in the pool.</b> Mesh seat noodles are also acceptable. Swimsuits that incorporate a flotation device as part of the suit construction are allowed. Residents are permitted to use therapeutic aquatic belts. Coast Guard approved life vests are also permitted.
<b>HEALTH:</b>	<b>PERSONS WITH OPEN WOUNDS ARE NOT PERMITTED IN EITHER POOL AT ANY TIME. LIFEGUARDS WILL ENFORCE THIS RULE.</b>
<b>GUESTS:</b>	Guests <b>MUST</b> be accompanied by a <b>RESIDENT</b> who must <b>REMAIN</b> with guests and have appropriate badges at all times. This applies to both adults and youth guests.

- FOOD:** Food and beverages are permitted in the pool area. NO GLASS OR OTHER SIMILAR CONTAINERS THAT MIGHT CAUSE PERSONAL INJURIES IF BROKEN ARE PERMITTED IN THE POOL AREAS. **NO ALCOHOLIC BEVERAGES ARE PERMITTED IN THE POOL AREAS.** Tables and surrounding area are to be left clean.
- SMOKING:** Smoking is not permitted within the pool area
- LOUNGES, CHAIRS, TABLES** Lounges, chairs or tables are not to be reserved with a towel, etc. **When leaving the pool area chairs and lounges are to be returned to their proper places.**
- UMBRELLAS** Umbrellas are to be opened by the lifeguards.
- SHOWERS:** Bathers are required to shower before entering the pools. If water shoes are worn please rinse before entering the pool.
- JACUZZI:** Residents are to read and follow rules posted at the Jacuzzi.  
**No one under the age of 16 is allowed in the Jacuzzi.**

**ALL RULES AND REGULATIONS WILL BE STRICTLY ENFORCED.**

It is hoped BOTH residents and guests will understand the rules and follow them.

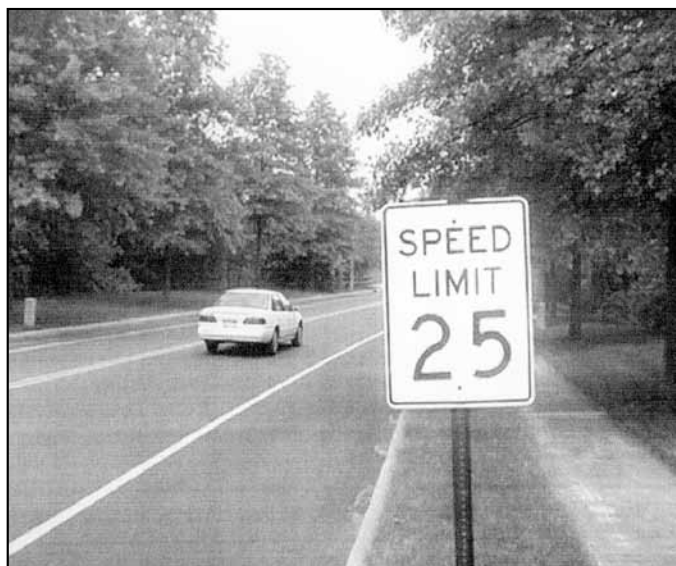

9:45 -11 a.m.: Located on the site of the former Liberty Deli, which supplied rescue workers supplies in the aftermath of the horrific events of 9/11, is the 9/11 Tribute Center. The center is a project of the September 11<sup>th</sup> Families' Association providing those who want to learn about the attacks of 2001 with the stories of those who experienced them. A 10 a.m. group admittance has been reserved to explore the galleries at your own pace.

# Nature Club

## Island Beach State Park

Island Beach State Park is a gem among our local state and county parks. Enjoyed by thousands of summer visitors headed for the swimming areas, the park is also a wonderful place to enjoy nature at any time of year. Miles of undeveloped landscape await the visitor. South of the two bathing beaches, many small parking areas are access points to footpaths leading over the dunes to the wide ocean beach. Trails on the west side of the road lead visitors to the bay, through maritime forest and freshwater wetlands. Bird watching blinds and canoe and kayak launching spots are located on the bay side of the park.

Where does the name island beach come from? Today’s maps do not show an island here, but in 1750 it was an island, created by Cranberry Inlet, located in present day Seaside Heights. This inlet allowed Toms River to become an important seaport during the Revolutionary War years. The inlet closed naturally

around 1812. Barrier islands are sculpted by ocean waves, currents and storms. Inlets open and close, as we saw during Super Storm Sandy in 2012 when an inlet was created in Mantoloking and has since closed.

At the June 27 meeting, speakers Al Sbarrow and Hailey Conrad, volunteers with Island Beach State Park, spoke about the human history of the Park. The earliest visitors were Native Americans who left evidence of temporary summer encampments for fishing, hunting and gathering food supplies. Henry Hudson’s 1609 trip records the first description of the Barnegat Inlet. The fascinating history of the land that would become Island Beach State Park includes piracy, coast guard stations and commercial ventures. In 1926, Island Beach was purchased for the development of a resort. The stock market crash and Depression era halted this plan and saved the area for our enjoyment as a natural area. Island Beach was sold to the state of New Jersey In 1953.


There will be no meeting of Nature Club in August. The next meeting is the fourth Monday in September.

# Fishing Club News

## Interesting Facts about Fish

1. Scientists have explored only 1% of the ocean depths. They believe millions of new kinds of animals and fish are down there, waiting to be discovered.

2. Humans have been amazed for centuries that salmon, after journeying across the ocean, can find the river where they were born. In the Yukon River in Alaska and in Canada, certain tagged Chinook salmon covered nearly 2,000 miles in 60 days. Salmon also have adapted to live in a variety of aquatic environments, including rivers, lakes, estuaries, coral reefs and the open sea.

3. Fish were the first vertebrates with bony skeletons to appear on Earth. Unlike today's fish, early fish had no scales, fins, or jawbone, but they did have a dorsal fin.

4. Hagfish are some of the slimiest animals on earth. An Atlantic hagfish can make enough slime in one minute to fill a bucket.

5. Unlike bony fish, sharks and rays do not have swim bladders. They have to swim all the time, even when they are sleeping. Otherwise, they will sink to

the bottom of the ocean.

6. A seahorse can move each of its eyes separately. One eye can look forward while the other looks backward. Seahorses can also change their color to match their surroundings.

7. Most types of seahorses pair for life. Female seahorses lay their eggs inside a pouch on the male seahorse's belly. When the babies are ready to hatch, the male holds onto a piece of seaweed with his tail and rocks back and forth until the babies pop out of his pouch.

8. Unlike most other fish, the ocean sunfish does not have a tail. A female sunfish can lay 300 million eggs each year. Each egg is smaller than the period at the end of a sentence.

9. The term "fish" is used when referring to one species of fish. For example, 10 salmon are 10 fish. The term "fishes" is used when referring to more than one species. 10 salmon, 3 trout and 1 angel fish are 14 fishes.

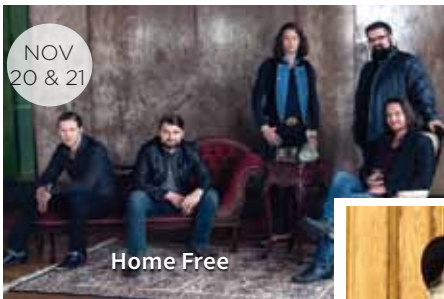
# Garden Club
