# **Board of Trustees Meeting- June 5, 2019** Willow Hall

Present were L. Maiocco, C. Lupo, E. Murphy, F. Weinstein, A. Damato and S. Tozzi. Also present were Community Manager – J. Schultz, Service Manager – J. Snyder, Accounting Administrator – M. O'Connor and Recreation Director – M. Lighthipe. Excused from this meeting was S. Falk-Zitelli.

This meeting commenced at approximately 1:00 pm with the pledge of allegiance.

APPEARANCES: Steve Wolff and James Adagardy from Viking Pest Control were present to explain their services. They are a paperless company and do need the residents email address to provide a copy of the completed service ticket. After the preventive service, they do place a barcode on the garage door frame; this is to track when a service was provided at the unit. The Association contracted with Viking for wood destroying insects, residents may seek additional services for a fee of \$37.00 with a 30-day warranty. Units are serviced based on a resident or the Association putting a service ticket in. If the technician is at one unit, service will only be provided to that unit. By law each unit needs to be marked out and scheduled. Resident questions and comments followed. Mr. Wolff and Mr. Adagardy left at 1:21pm.

#### ITEMS VOTED ON: (continued in Community Manager's Report and New Business)

F. Weinstein moved to waive the reading of the minutes. C. Lupo seconded. All present were in favor. Motion carried.

F. Weinstein moved to approve the May 15, 2019 minutes. C. Lupo seconded. All present were in favor. Motion carried.

A.DAmato moved to approve to purchase the XMark 72" Laser S Series Mower from Lakehurst Lawn Mower for a total cost of \$11,979.32 which includes shipping and tax. This expense will be provided by account #3150 – Property Fund – Replacements. The unaudited balance for this account as of 4/30/19 is \$828,878.37. S. Tozzi seconded. All present were in favor. Motion carried.

M. Lighthipe, Recreation Director gave a report for the Recreation Department.

#### COMMUNITY MANAGER REPORT: (J. Schultz & J. Snyder – Service Manager)

The solar panels are currently being installed at Club Encore. The panels for the Association building will arrive on June 6th. The lease began on June 1st. KLVW created a recycling video explaining restrictions. It was suggested that KLVW continue replaying this video. It was stated at a previous meeting that the visitor's lists are being purge, it will be extended until Friday, June 7th. Residents are asked to review and make any revisions to their list prior to Friday. Reminder that Residents must receive a permit from the Association office to perform for any work in their five-foot area. Road Paving Update: next week milling will be taken place on the main drag of Cambridge Circle and residents in that area will receive a one-call with prior notice.

The roadways in our community need to be re-striped. The following bids have been received to stripe Buckingham Drive from the 37 gate to the bridge, and the roads that have been paved on Cambridge Circle. The sales tax has been added into the quotes received.

After discussion and the recommendation from management, F. Weinstein moved to approve to contract with Straight Edge Striping to do the striping of Buckingham Drive for a total cost of \$11,909.80 and do the striping on Cambridge Circle for a total cost of \$6,618.75. The total cost to stripe both areas are \$18,528.55. This expense will be provided by account #3290 – Capital Replacement Roads. C. Lupo seconded. All present were in favor. Motion carried.

The Association previously contracted with an engineering company, Global Hydro, Inc. to see if it was possible to get the Well Water Allocations from the DEP adjusted to meet our needs. They have completed the initial tasks in Schedule A (See below) which were required in order to proceed with the application for the increases needed. On April 22, 2019, Global Hydro Inc., Dwyer Geosciences and the Service Manager, J. Snyder attended a pre-application meeting with the D.E.P to discuss the findings. An initial study proved that we have a good case for increasing our monthly water allocations from 24 million gallons to 37 million gallons as long as we do not exceed our yearly allocation of 142 million. If approved, this will allow us better utilization of our water when needed.

2. Residents were previously notified that Bingo was suspended until further notice. E. Murphy moved to approve to dissolve the existing Bingo Club, its officers and to transfer funds to the Association until the new Bingo Club is formed. F. Weinstein seconded. All present were in favor. Motion carried. This will be

COMMUNITY MANAGER REPORT: J. Schultz and J. Snyder, (Service Manager)

J. Schultz gave an update on the solar project for the Association building; the size of this project was reduced and the Association opted to begin the lease early. Visitors lists are being purged today. When new roofs are installed on the units, the Association will replace the gutters with the larger 6-inch size. The gutter guards will not be replaced. The Maintenance Department is not removing the existing gutter guards. Anyone that needs a gutter cleaning can call the Maintenance Department.

J. Snyder mentioned that there is a pilot program with the walkway lights to enhance the areas with more lighting. Walkway lights are not being eliminated. Paving in the Cambridge Circle area will be completed today and line striping/parking spots will follow. The Club Encore kitchen grease trap is original to the building and is no longer working properly. Bids were received and the results are as follows:

He is recommending to contract with Toms River Heating and AC to install a new 100lb grease trap for \$1,757.00 and complete the masonry work in-house for a total cost of \$2,757.00. This expense will be provided by account #3150 – Property Fund-Replacements. The Board will vote on this at the next open Board meeting on July 17, 2019.

**Resident:** J. Ercolino reminded residents that there are volunteers at the paper trailer this week around 9 am. The truck that picks up the papers at the units leaves at approximately 8 am. It has been reported that people are leaving trash at the paper trailer. He is inviting the Board of Trustees to attend the Recycling Clubs meeting on Tuesday, June 11th at 1pm in Club Encore to discuss how to handle the fines for dumping at trash at the paper trailer.

**Resident:** A. Pedowitz spoke in regards to the issue with the Bingo Club and who is allowed to attend. He believes that the term guest has been misused regarding the Bingo Club.

Resident: R. Scordato spoke about the payment in advance from residents to Hotwire Communications for services. He stated a reimbursement issue arose when Verizon took over. He asked if any follow up to Hotwire is being done for reimbursement to the residents for the period of time when it was not used and payment was still made. He also asked if there was a reimbursement for the bulk television service as well. He also suggested that in the future an attorney specializing in contracts be hired when contracts are made for the Association

She also has not seen anyone use the Café. She asked why it was built. She thanked the Caritas Club for the generous donation to the St. Vincent Paul Organization at St. Johns Church.

**Response:** The food is inspected by the Vendor once a week, by law they are tagged with a stale date and then discarded. With the nice weather approaching and more activities going on in the Village hopefully Residents will use the Café.

**Resident:** D. Miller stated that there is a squatter living in a unit a few doors down from hers for over a month. She expressed her concerns that there is no electricity to the unit but can see flickering lights from candles and the pets living in the unit as well.

**Response:** The Board has been made aware of the situation and with the local and State authorities they are actively trying to take care of this matter.

**Resident:** R. Scordato asked if the Association is paying a small fee to Verizon besides the bulk television service.

#### Response: No.

There being no further comments or questions, the meeting ended at approximately 2:35 pm.


# Audience Comments-June 19, 2019

# "Election 2019 - Important information from the Election Committee"

**BALLOTS** will be mailed on Monday, **August 5**, 2019. Following instructions, complete, sign and return your ballot in the self-addressed stamped envelope provided. Your vote counts; these ballots count toward quorum.

**ELECTION DAY** this year is **Friday**, **August 30**, **2019**. Polls open at 7 am. Anonymous (paper) ballots and voting machines will be available until 1 pm.

*To vote in person*: Voters will proceed to one of three poll positions, based on your address, where you will present ID containing your unit address. Voters in good standing will **sign the poll book**.

- If you are In Good Standing and *not yet voted*: you can choose to vote anonymously by <u>paper ballot</u> or <u>voting machine</u>.
  - Anonymous paper ballot: proceed to the private area provided, complete your ballot, return it to the same poll location and leave the area.
  - > Voting machine you may proceed, cast your vote and leave the area.
- If you are In Good Standing, have *already voted by mail* and wish to *change your choice(s)*: your ballot will be pulled, marked **VOID** and deposited in a clear container for destruction.
  - Anonymous paper ballot: proceed to the private area provided, complete your ballot, return it to the same poll location and leave the area.
  - > Voting machine you may proceed, cast your vote and leave the area.

**The Annual Meeting of the Members** will commence at 12:30 p.m., voting will continue until 1:00 p.m. at which time the polls will close. *IF WE MEET QUORUM*, (minimum of 1347 ballots received), the meeting will be suspended, counting will commence in the Auditorium, and continue until all votes are tallied. The meeting will then resume and results will be published. [*If there is no quorum, voting cannot commence and the meeting will be adjourned for 30 days* so *PLEASE* return your ballot envelope].

# Get Your Feet Wet, While You Contemplate

Don't let summer pass you by, head over to one of your swimming pools and enjoy a dip in the pool or sit poolside and read a good book. Sadly, it won't be too long before the fall creeps up on us and the weather turns in favor of pumpkin spiced beverages.

This pool season has been a very trying one, as we switched vendors over the previous year. Maybe it's just a sign of the times as it's become increasing more difficult for companies to find lifeguards who take their jobs seriously. With the notably troubling performance, the topic will surely focus on what will happen next season? Will we have guards or not?

This is a confounding problem for the Board to contemplate. As you will remember, the law changed again this past year that allowed us to file to be exempt, therefore allowing us to function without the use of lifeguards at all. Specifically the latest change in the law reversed a previous restriction and allowed us to have one guard, where two is the minimum for non-exempt large pools like ours. Seemingly, that would have been the best and most practical decision, bringing the operation back to the way it historically had always been done, one pool, one guard. Unfortunately, when viewed through the eyes of an attorney, this sensible decision became more problematic, as it created a contradiction when signage would say "swim at your own risk" but a lifeguard could be present. This ambiguity would cause concerns for any attorney and understandably they would advocate not to move forward with that type of procedure.

So, with a little Déjà vu, the Board will once again ponder the problem for next season. There have been alternative solutions put forward but not overwhelmingly acceptable ones. Who knows what form next year will take? You may have even heard of a solution that would have two guards at one pool and the other pool exempt. Would that scenario prove acceptable, especially if the exempt pool did not allow children? How about you, do you have an idea? Perhaps there's a better solution out there.

# Willow Lake Boating Rules

Leisure Village West Association boats are available for use under the following conditions. Boats are available for use from April 15 through October 15.

1. Each boat *must* be restricted to four passengers, of which not more than two are adults.

2. Each boat occupant *must* wear a life jacket when in a boat. Life jackets are kept in the Gazebo on the pier.

3. Boats *must* be docked and entered from the shore line, *not* from the dock.

**4.** Boating is restricted to daylight hours.

5. Upon return, boats are to be pulled out of the water onto shore. Oars are to be placed inside boat. Life jackets are to be returned to specified area of Gazebo.

6. Guests under 6 years of age are *not* permitted in the boats. Guests from 6 to 16 years of age *must* be accompanied by an adult.

7. All guests *must* be accompanied by a resident.

**8.** *No* swimming or wading in any body of water other than the Village pools.

9. No standing in boats.

**10.** *No* one shall go out in a boat alone.


# Men's Inside Golf August is LVW Golf Championships Season

We had an outstanding guest speaker, Matthew Kalwinsky, Esq. of Taff, Davies & Kalwinsky, Toms River, NJ who discussed Elder Care Law and Estate Planning.

Mr. Kalwinsky's presentation was extremely interesting, relevant, thorough and engaging. As he described Estate Planning, he created a comfortable atmosphere for our members to ask questions and share personal experiences.

POWER OF ATTORNEY: A document where the client gives someone else the authority to make legal and/or financial decisions for them. It can be as simple as allowing someone to sign a document (perhaps a deed) for them, or it could give someone the power to make decisions for them (perhaps if they became incapacitated) in financial or health matters.

LIVING WILL: This is a written statement detailing a person's desires regarding their medical treatment in circumstances in which they are no longer able to express informed consent, especially an advance directive.

WILL: Mr. Kalwinsky encouraged those who have assets and heirs to prepare a Will. If a person dies without one, then the Probate Court would appoint an Administrator to make distribution of their estate. The Administrators decisions concerning distribution may not be in line with the desires of the decedent. Further, it can be very costly and time consuming. Thus, if one has an estate that is valuable, a Will would allow it to be distributed the way they desire and will save time and money.

Some other topics discussed were guardianships, inheritance tax and tenants in common.

## Leisure Village West Willows & Pines Golf Course Regulations



For the enjoyment of the game of golf and for the proper care and maintenance of the golf courses, the following regulations will apply:

Golf courses officially open at 8:00 a.m. from April to October unless otherwise posted. <u>*Players must be 16 years of age.*</u> Children and pets are not permitted anywhere on the golf course including sand traps and greens.

### **General Rules:**

- 1. Residents and guests must carry a LVW Identification card. Residents must accompany guests.
- 2. Metal spike golf shoes are not allowed.
- 3. All players and guests must sign in for each 9 holes. No more than a foursome may play in a group. Tee off is in order of sign-in.
- 4. Each player must have a minimum of 2 clubs, one of which must be a putter.
- 5. All play begins on the first hole. The ball must be teed-up on all holes between the markers and no farther back than two club lengths.
- 6. The <u>second</u> hole tee box must be cleared of players before teeing off from the first tee on both courses. The ninth tee box at the Willows must be cleared of players before teeing off from the eighth tee.
- 7. Flag sticks and equipment must be kept off the greens.
- 8. <u>All players must replace divots, rake sand traps and repair ball marks on the green</u>. Please repair your mark and one other, if necessary, to maintain the integrity of the course.
- 9. Out of bounds: Areas outside the white markers and sidewalks are out of bounds. Place ball inbounds at the point where it left the fairway.

#### Please Note:

<u>Practice putting green</u>: A putter only is allowed. No chipping or pitching onto the green. <u>Tournaments</u>: Special rules are set forth by the tournament sponsors.

#### Maintenance Schedule:

Pines & Willows course: Closed <u>only when spraying</u>. Watch channel 1970 Creeper and lvwcreeper.com for spray dates.

Course maintenance will continue while play is in progress. Please cooperate with the workers.

Winter Schedule: Starting times and rules will be posted.



Over the past two years, over 350 various LVW residents have joined us (not at the same time!) on Thursdays for fun evenings of conversation, laughter, and friendship.







#### Youth guests under 4 years of age are not permitted in either pool.

In the event of the closing of one pool; the youth guest hours are as follows at the opened pool 11-1 pm and 4-7 pm. A 20-minute grace period will be allowed for children to exit the pool area at the end of the children's swim hours. Children are not allowed in the pool area at any time other than designated youth hours. Children 10 years of age and under must be supervised by a parent or grandparent for the entire time they are in the water.

### Unsupervised children will be asked to leave the pool after calling their guardian. Roughhousing and horseplay will not be tolerated.

#### POOL ENTRY:

Members must swipe their photo ID badge for verification of member status at the pool gate in order to obtain admittance to the pool area.

- **GUESTS:** Up to (4) adult or youth guests are permitted and MUST be accompanied by a RESIDENT who must REMAIN with guests at all times.
- **ATTIRE:** Proper swim attire must be worn from home to pool since the changing area is limited. Cut-off jeans are not allowed in the pool. A cover-up wrap is needed when entering the

clubhouses. The Association is not responsible for any discoloration of bathing suits due to pool chemicals. Street shoes are not allowed in the pool. DO NOT LEAVE SHOES OR SLIPPERS AT THE POOL STEPS.

- DIAPERS: Only diapers specially designed for immersion in water are permitted.
- **SAFETY:** NO DIVING OR JUMPING IS ALLOWED AT EITHER POOL AND WILL BE STRICTLY ENFORCED. NO SITTING OR STANDING ON POOL STEPS UNLESS WHERE INDICATED AT THE ENCORE POOL. Weather related closures are at the discretion of the lifeguard. The lifeguard will determine when to reopen the pool. Lifeguards do remain on duty during rain.
- SWIM AIDS: NO floats, toy surfboards or swim toys are permitted in the pool with the exception of noodles. Noodles are not to exceed two per person. Mesh seat noodles are also acceptable. Swimsuits that incorporate a flotation device as part of the suit construction along with swimmies are allowed. Residents are permitted to use therapeutic aquatic belts. Coast Guard approved life vests are also permitted.

### HEALTH: PERSONS WITH OPEN WOUNDS ARE NOT PERMITTED IN EITHER POOL OR JACUZZI AT ANY TIME. LIFEGUARDS WILL ENFORCE THIS RULE.

- FOOD: Food and beverages are permitted in the pool area. NO GLASS OR OTHER SIMILAR CONTAINERS THAT MIGHT CAUSE PERSONAL INJURIES IF BROKEN ARE PERMITTED IN THE POOL AREAS. NO ALCOHOLIC BEVERAGES ARE PERMITTED IN THE POOL AREAS. Tables and surrounding area are to be left clean.
- **SMOKING:** Neither smoking nor vaping are permitted within 25ft of the pool area. Please use designated areas.
- LOUNGES, Lounges, chairs or tables are not to be reserved with a towel, etc.
- CHAIRS, TABLES: When leaving the pool area chairs and lounges are to be returned to their proper places.
- SHOWERS: Bathers are required to shower before entering the pools. If water shoes are worn please rinse before entering the pool.
- JACUZZI: Residents are to read and follow rules posted at the Jacuzzi. No one under the age of 16 is allowed in the Jacuzzi.
- MUSIC: Please use headphones where possible, otherwise be considerate and keep the volume down as not to disturb fellow members.

#### It's tricky to know what is recyclable in Ocean County Listed are some of the most common problems.

#### **BOTTLE CAPS**

Please remove all bottle caps and toss them in the trash. Bottle caps cause problems at our recycling facility. When bottles are crushed, tops can eject and hit workers. Having the tops off ensures liquids are out. So caps ahoy.

#### PLASTIC BAGS

The average active use of a plastic bag is 12 minutes! But plastic bags take 10-400 years to decompose. Plastic bags are prone to jamming machinery at recycling facilities. Please do not put your plastic bags in recycling. Do not use a plastic bag to contain recyclables. A bin or other container is required. Bring your own bags to the grocery. You can do it!

#### **PIZZA BOXES**

Pizza boxes are made from corrugated cardboard. However, when the cardboard becomes soiled withgrease, cheese, and other foods the box becomes contaminated. Food contamination is worst in paper recycling. It renders those paper items non-recyclable. So into the trash go the pizza boxes.

When in doubt if something is recyclable, don't recycle it. Just because an item labels itself as recyclable, it may not be recyclable in your location. Recycling facilities have differing regulations.





Although hurricane season begins in June and ends in November the more active months typically are August and September. Summer storms bring heavy rains and winds, lightening and downed trees that can cause power outages. Being prepared is the major key to staying safe and informed.

Every six months your emergency supplies should be updated. Be sure to have a flashlight, extra batteries and a portable radio within easy reach. Maintain an emergency supply of water, canned food, such as tuna, canned meats, vegetables, fruits and juices and don't forget the can opener. Remember a portable cell phone charger. Also check your go kit to be sure you have all you need should you have to leave your home.

The safety and care of our pets is just as important and they should have their own emergency supply kit. This should include a supply of water, non-spill food, leashes, cage or carrier and medication just to name a few items.

Register Ready is New Jersey's special registry for disabled residents which assists emergency responders in identifying persons with special needs during an emergency. Manchester Township Office of Emergency Response also maintains a registry. LVW Association should be advised of special needs during an emergency as well. 

We're always looking for new talent, either in front of the curtain or behind it. Please remember, all the world's a stage and all the men and women, merely players. Come be a player!





Summertime and the bees are busy visiting our gardens. Honey bees (Apis) are hard workers. They collect pollen, pollinate food crops and produce honey. One third of all the food we eat depends on pollinators, usually bees. Bees are an asset to commercial agriculture. Honey bees live in colonies and are transported in their hives to orchards and farms at the time their work is needed. Currently it's alarming that many honey bees are dying, a phenomenon called "colony collapse". The reasons for a global decline of bee colonies are industrial agriculture, parasites/ pathogens and climate change. Toxic pesticides are particular threats for both honey bees and wild pollinators.

lots of pollen. USDA research shows that one Mason bee can do the job of 100 honey bees. Mason bees work in cool and rainy weather. Where early spring crops are waiting, Mason bees are ready when honey bees are apt to take the day off.

Mason bees are also suffering increased death rates but seem to be hardier than honey bees. Because the native bees live independently they are less susceptible

to disease and pests and they can't be transported to farms where exposure to toxins is greater.

Mason bees are named for their use of mud in nest building. They lay eggs in cracks or holes which they seal with mud. Orchard and Blueberry bees are smaller than honey bees and have a metallic green or blue color. They are solitary but like to nest near one another. These bees are docile and only sting when handled.

To attract and protect these hard working little pollinators we can provide artificial nesting holes. Housing for Mason bees can be made with bundles of waterproof tubes or reeds. The preferred size of nesting holes is 6 inches long and 5/16 to 3/8 inch inner diameter. These nesting houses should be placed in a sunny spot protected from rain.




