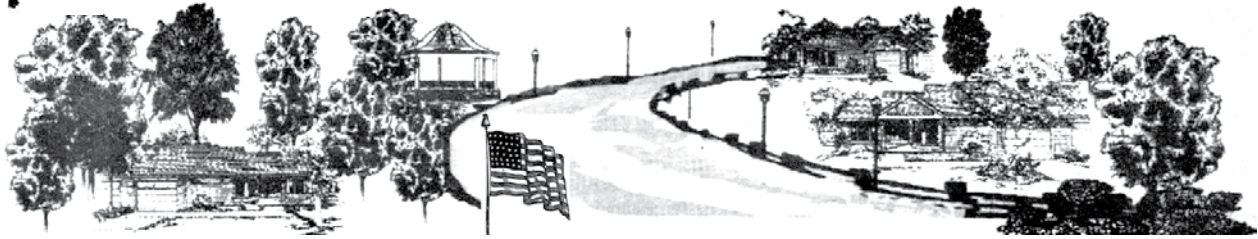

Board of Trustees Meeting – May 4, 2016

Present were Sandra Kaufman, Sal Tozzi, Sue Nordell, Russ Steenweg, Marge King, Charles Lupo, Lou Maiocco and Community Manager Joseph Schultz.

The meeting commenced at approximately 1 p.m.

T. Londner, a member of the Election Committee, swore in L. Maiocco.

S. Kaufman thanked C. Frattini for his many years of service. She welcomed L. Maiocco to the board and believes he will be a positive addition.

S. Nordell moved to approve the April 6, 2016 and April 20, 2016 minutes. C. Lupo seconded. All in favor. Motion carried.

S. Tozzi moved to authorize the Association to contract with C.J. Hesse to replace the outside roads of Thornbury Lane for a total cost of \$217,425.50 and for Huntington Drive & Buckingham Drive side roads for a total cost of \$112,350.50. The total cost for both projects is \$329,776.00. The funds to meet this expense will be provided by account # 3290- Capital Replacement-Roads. C. Lupo seconded. All in favor. Motion carried.

C. Lupo moved to approve the Election Policy. S. Nordell seconded. Discussion ensued. S. Tozzi moved to table the motion. M. King seconded; S. Nordell, No; S. Tozzi, Yes; L. Maiocco, Yes; R. Steenweg, No; M. King, Yes; C. Lupo, Yes; S. Kaufman, No. Motion tabled.

C. Lupo moved to approve the amended Election Committee Charter. S. Nordell seconded. All in favor. Motion carried.

R. Steenweg moved to approve the Amended Door to Door Policy, a copy of which is attached to and made part of these minutes. C. Lupo seconded; S. Tozzi, No; L. Maiocco, Abstain; M. King, No; R. Steenweg, No; C. Lupo, No; S. Nordell, No; S. Kaufman, No. Motion failed.

L. Maiocco moved to approve the Italian American Social Club bylaws. S. Tozzi seconded. All in favor. Motion carried.

M. King moved to authorize the Association to contract with Roofing Masters to replace 9,231 linear feet of gutter at \$3 per foot for a total cost of \$27,693.00. The funds to meet this expense will be provided by account #3270- Capital Replacement-Roofs. S. Tozzi seconded. All in favor. Motion carried.

S. Tozzi moved to memorialize the Association's payment to Curry Electrical Contracting for replacements of electrical panels at 57A Edinburgh; 29D Edinburgh; 13B Cambridge; 17A Gramercy; 60A Buckingham and 1A Edinburgh for a total cost of \$5,256.00. The funds to meet this expense were provided by account #3295- Capital Replacement- Exterior Restoration & Unit Infrastructure. R. Steenweg seconded. All in favor. Motion carried.

S. Nordell moved to authorize the Association to purchase three pumps and three motors from Ferguson Enterprises for a total cost of \$4,606.41 charged to account #3260- Capital Replacement Fund- Irrigation/ Well Motors. C. Lupo seconded. All in favor. Motion carried.

Manager's Report

J. Schultz introduced S. Bowker as Secretary and thanked A. Devito for all her hard work and helping with the transition of positions.

J. Schultz reminded residents that the Mayor will be coming to the Board meeting on May 18, 2016 at 7 p.m.

J. Schultz notified all residents that they may have received a Robo call from the township regarding energy increase. He mentioned that this is a scam.

Old Business (Items Pending)

Bylaws amendment was explained to the residents regarding Renewal lease fees. Any questions regarding this amendment can be discussed at the July 20, 2016 Board meeting. A brief recess took place.

J. Schultz stated there will be a meeting held between the Board members and Hotwire. He will then notify the residents on the results of that meeting.

The board has decided to go with a contractor for the vinyl fence replacement project. J. Snyder is working on getting more bids.

M. King asked J. Schultz if the Association had enough wood to replace 70 sections and why it's necessary to replace all for such a high amount right now.

Discussion took place about brown fencing and it was decided this was too expensive. More detail will be provided at the next board meeting.

Division Charters were voted on. S. Nordell made a motion to approve the Administration Division Charter. M. King seconded. All in favor. Motion carried.

S. Tozzi made a motion to approve the Finance

Division Charter. S. Nordell seconded. All in favor. Motion carried.

R. Steenweg moved to approve the Plant/ Architectural Division Charter. C. Lupo seconded. All in favor. Motion carried.

M. King made a motion to approve the Resident Services Charter. S. Nordell seconded. All in Favor. Motion carried.

S. Nordell made a motion to approve the Advisory Council Charter. M. King seconded; S. Nordell, Yes; L. Maiocco, Yes; R. Steenweg, Yes; C. Lupo, No; M. King, Yes; S. Tozzi, Yes; S. Kaufman, Yes. Motion carried.

R. Steenweg made a motion to approve the ADR Charter. S. Nordell seconded; S. Nordell, Yes; L. Maiocco, Yes; R. Steenweg, Yes; C. Lupo, Yes; M. King, Abstain; S. Tozzi, Abstain; S. Kaufman, Yes. Motion carried.

New Business

The solicitation letter will be published in the June magazine for anyone interested in running to be a trustee.

M. King thanked residents that volunteered on Earth day to help clean the village. She mentioned they had found some interesting items.

Audience Comments

S. Bailey made a comment about soliciting in the village and would like a policy on how it is done.

C. Brignola found another resident to be insulting to a trustee member and feels hand gestures are inappropriate.

S. Zitelli mentioned that she believes the Door to Door policy came about from the Manchester Times. She also believes the board needs to come to a resolution on this issue and establish something. She also was not contacted regarding the changes being made to the Resident Services charter.

M. L. Ruggiero asked for an explanation from the board as to what happen to Alice.

C. Van Den Heuvel mentioned she is aware of a letter received by the board from the New Jersey Disability Association and that our attorney has responded that a community announcement was made. She believes she was not notified and would like an explanation. She also believes because the contract

previously with Classic Tours had wheelchair access that the new one should as well.

J. Ercolino stated the Door to Door policy was knocked down and spoke about the continuing Hotwire issues. He also mentioned two paint cans were left at the newspaper container and to have someone check the cameras.

J. Schultz asked H. Height to review the cameras by the newspaper container to see who left carpeting.

M. Lamberti said the graphics on the television for the meetings are great. She questioned the board on how the bylaws were accepted for the Italian American Club and how the group was formed.

S. Zitelli said there was always a memorial service that took place at Club Encore for the Veterans and asked why nothing was going on.

C. Brignola told residents the VFW was no longer in the village and that we only have a Veterans Club. He stated everything has now been brought into one. He mentioned they meet Monday, May 9, 2016 at 7:30 p.m. in Willow Hall. They will be holding a service on both Memorial Day and Veterans Day and he welcomes anyone to join from any branch of service.

W. Dylewski stated the he believes the board is disrespectful to volunteers.

K. Spontak stated she is working with G. Caravella on the trees in the village and maintaining those resources. She spoke about employee safety while working on trees. She thought the board could look into getting a bucket truck.

A. Damato suggested the board look into a used bucket truck. He asked for an explanation regarding the management fee to a Leisure Village West rental unit. He asked if L. Maiocco's resume would be posted on the creeper.

K. Maiocco questioned the Door to Door policy and how to handle visitors. She mentioned the security in the village and that nothing is one-hundred percent guaranteed secure. She remembered the veterans club already being discussed.

C.H. Matosin told the board she caught another criminal in the village and that if a resident sees something they should report it even if it's something minor. She mentioned other crimes that happened on Sterling Street.

A. Weiner asked the board if the Hotwire contract was sent to our attorney and if it can be posted on the

LVW Creeper.

R. Cohen mentioned her biggest pet peeve is when a vote comes up with the board and a Trustee chooses to abstain.

P. Masterson thanked the maintenance department for fixing her neighbors doors when there was an emergency. She mentioned the yellow dot program and the emergency personnel needs to be more informed about it.

S. Zitelli said social services provides the yellow cards and they are responsible for notifying emergency personnel.

There being nothing further to discuss, the meeting ended at approximately 3:45 p.m.

1. Members seeking nomination to the Board of Trustees **must** be a recorded-owner in order to fulfill the duties of the office.
2. Name and address of the nominee.
3. A written petition of nomination bearing the genuine signatures of not less than fifty (50) members.

The official LVW petition is available at the Association office and to be on www.lvwcreeper.com. ONLY ONE (1) MEMBER PER UNIT SHALL SIGN THE PETITION.

4. This petition will be validated, by the Accounting Staff, as to the status and good standing of the signatories. (This paragraph and the requirement therein, is not applicable to persons who are currently or have previously been Trustees.)

IF ANY OF THE ABOVE REQUIREMENTS are not complied with, the petition shall be declared to be invalid and the candidate shall not be accepted in nomination.

In addition to the above, the candidate should include the length of time of their residency in the Village; and any additional information which the candidate may believe helpful for the purpose of acquainting the membership with their ability and qualifications. This information will be included in a special Election Bulletin and on LVW media.

The Election Committee will publish the names of the validated candidates on LVW media, no later than close of business, Friday, August 5, 2016.

Any member wishing to challenge the nomination of any candidate must do so, in writing, NO LATER THAN Tuesday, August 16, 2016. Challenges must be mailed to the Board Secretary of the Association. Challenges are limited to questions of compliance with the Election Policy, rules, procedures and Bylaws. Challenges as to the candidate's qualifications will not be accepted.

The Secretary of the Association will deliver the challenges to the Chairperson of the Election Committee to determine the validity of the challenges within two (2) working days of its receipt.

If the challenge stands, the Chairperson of the Election Committee shall so notify the nominee. The challenged nominee may appeal the decision directly to the Board of Trustees, within three (3) working days of the date of the decision. The Board of Trustees shall adjudicate the appeal within two (2) working days of receipt of the appeal. If the challenge is upheld, and the appeal denied, the candidate shall be so informed and his/her name withdrawn from the ballot. The decision of the Board of Trustees shall be accepted as final.

A list of those nominated and other procedures and information relevant to this election shall be included in a Notice of Election.

Upon the execution of any lease for any residential unit within the Community the Lessor/Owner shall pay to the Association within 10 calendar days, a non-refundable and non-transferable fee in the amount as determined by the Association Board of Trustees. 2. All lease agreements shall, in all respects, conform with the governing documents of the Leisure Village West Association and its constituent condominiums, including but not limited to the Master Deeds and Declarations of Restrictions and Protective Covenants, the By-Laws, Rules and Regulations and published policies. Unit owners must file a certified copy of the lease with the Association on or before 10 calendar days, before the commencement of the lease or occupancy. 3. In all events, the Lessor/Owner shall, upon the earlier of execution of the Lease or tenant's occupancy, provide to the Association a copy of the lease and written notice of any extensions for any occupancy. The Association shall not collect an additional fee for a tenancy under any renewal or extension. The purchase of a unit by a tenant in possession, under the terms of a lease which contains a purchase option, a right of first refusal or similar purchase rights, shall not be an event which shall entitle the Association to payment of an Administrative Transfer Fee of the difference between the administration transfer and the administrative fee for lessors. 4. The Administrative fee shall be due and payable to the Association no later than 10 calendar days following the execution of the lease or commencement of the initial term, whichever occurs first. The Lessor/Unit owner's failure to pay the Administrative fee shall result in the filing of a lien against the unit in the sum as determined by the Board of Trustees, together with costs of filing and discharge, but not less than \$150.00 for the filing and discharge costs. 5. The Administrative Fee for Lessors shall not be charged or collected for any Lease or renewal of a lease, if the parties to the Lease are in direct lineal relationship, ascending or descending, but limited, however, to grandparent, parent and child. 	<ol style="list-style-type: none"> 1. In addition to the Master Deed and Bylaws, the leasing rules contained in the Resident Handbook shall govern all tenancies within the Association. 2. Bylaws Vote

You may have received your ballot in the mail for an important Bylaws vote, or you will be receiving it shortly. Your affirmative vote will allow the Association to charge a renewal fee for leases, not currently allowable under the existing bylaws. I recognize that this may be of little interest for most residents, but we want you to be aware that your vote is important and we'll be counting on you to see that this succeeds.

The material included with your ballot is probably enough for you to make an informed decision, however if you're still unsure, you should plan on attending the July 20 meeting in Willow Hall at 7 p.m. You could also come to any Board meeting between now and the July 20 meeting and ask your questions.

Once you've made up your mind, be sure to mark the appropriate spot on the ballot of yes or no, print your name, fill in the date, sign the ballot, place it in the stamped envelope provided and mail back to the Association Office. That's it!

Please note the following:

- We'll need 1,347 votes to have an official meeting and referendum.
- We'll need a minimum of 1,373 affirmative votes, representing 51 percent of the unit owners to pass the amendment.
- You must sign and date your ballot, we must be able to prove YOU voted.
- Your ballot must be postmarked by July 19.
- You may also vote or change your vote, in person at the July 20 meeting.

# Yoga Thrives

## Working with Breath

By Linda Kay

Hatha Yoga, yoga's physical postures, are only one of yoga's eight practices. Another practice involves breathing and is called pranayama. 'Prana' refers to the life-force that unites the body, mind, and spirit. Breath work helps to calm the mind and bring healthy oxygen into the body.

You know how your breath is when you're stressed; it's shallow and rapid. Fortunately, the reverse is true. You can deepen and slow down your breath and your 'flight or fight' response will decrease.

Here are some simple ways to work with the breath:

1. Imagine that your lungs are a drinking glass. As you inhale, pouring slowly, fill the bottom of the glass and continue until you are near the top (just under your collarbones). Exhale slowly, as though sipping through a straw, emptying the glass from the top down.

2. Find someplace where you can see or hear a clock counting out seconds. Sit up as tall as comfortable and relax as much as possible. Take a slow inhalation without any extra effort and note how many seconds it took. Then take a slow exhalation of equal length. Take a number of breaths in this fashion and relax into the experience.

After breathing this way for a time, you may notice that you want to take longer breaths. Increase the number of seconds gradually. Slow breaths let the body know it's safe. If you feel dizzy or strange, just stop and take some regular breaths and begin again when you feel recovered.

3. As you inhale, bring your attention to the sides of your ribcage, below the armpits. Feel the ribcage expand with each inhalation and release with each exhalation.

4. With each inhalation, bring in what you want in life; and with each exhalation, release what you don't want.

The nice thing about these practices is, no equipment needed!

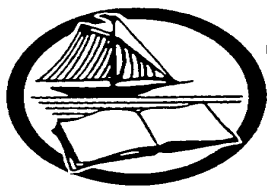

## **Leisure Village West Willows & Pines Golf Courses Regulations**



For the enjoyment of the game of golf and for the proper care and maintenance of the golf courses the following regulations will apply.

Golf courses officially open at 8 a.m. from April to October unless otherwise posted. **Players must be 16 years of age.** Children and pets are not permitted anywhere on the golf course including sand traps and greens.

### **General Rules:**

1. Residents and guests must wear appropriate badges. Residents must accompany guests.
2. Metal spike golf shoes are not allowed.
3. All players and guests must sign in for each 9 holes. No more than a foursome may play in a group. Tee off is in order of sign-in.
4. Each player must have a minimum of 2 clubs, one of which must be a putter.
5. All play begins on the first hole. Ball must be teed-up on all holes between the markers and no farther back than two club lengths.
6. The second hole tee box must be cleared of players before teeing off from the first tee on both courses. The ninth tee box at the Willows must be cleared of players before teeing off from the eighth tee.
7. Flag sticks and equipment must be kept off the greens.
8. All players must replace divots, rake sand traps, and repair ball marks on the green. Please repair you mark and one other, if necessary, to maintain the integrity of the course.
9. Out of Bounds: Areas outside the white markers and sidewalks are out of bounds. Place ball inbounds at a point where it left the fairway.

### **Please Note:**

**Practice putting green:** A putter only is allowed. No chipping or pitching on to the green.

**Tournaments:** Special rules are set forth by the tournament sponsors.

### **Maintenance Schedule:**

**Pines & Willows Course:** Closed only when spraying. Watch channel 15 creeper and Iwvcreeper.com for spray dates. Course maintenance will continue while play is in progress. Please cooperate with the workers.

**GUESTS:** Guests **MUST** be accompanied by a **RESIDENT** who must **REMAIN** with guests and have appropriate badges at all times. This applies to both adults and youth guests.

**FOOD:** Food and beverages are permitted in the pool area. **NO GLASS OR OTHER SIMILAR CONTAINERS THAT MIGHT CAUSE PERSONAL INJURIES IF BROKEN ARE PERMITTED IN THE POOL AREAS. NO ALCOHOLIC BEVERAGES ARE PERMITTED IN THE POOL AREAS.** Tables and surrounding area are to be left clean.

**SMOKING:** Smoking is not permitted within the pool area

# Garden Club

## Stop Crape Murder!

By Yvonne T Huacuja

*From the article by Paul Thompson of Clemson University Extension Service.*

Crape Myrtles are victims of over-zealous pruning by many folks. This destroys the structure and beauty of the tree, is an unwanted stress that often encourages pest problems, and it encourages a proliferation of shoots to develop and total loss of control. Proper pruning allows us to control and direct growth.

- Crape Myrtles may form a thicket of trunks that becomes unsightly over time. Select three to five trunks to develop when the tree is young and the trunks are a small diameter. Once you select the trunks to leave, keep all basal shoots pruned out when you notice them.

- As the young tree grows taller, you want to begin to develop the trunk character by removing the lower lateral branches so that the tree is about one-third trunk and two-thirds branches and canopy.

- Remove any crossing branches while the branches are still small. Crossing branches rub against each other and cause wounding.

- Selectively remove limbs within the canopy that are weak or overly crowded.

- If you find the seedheads objectionable, you can remove them by pruning above a lateral bud. If you do not remove them, they will fall off on their own as the growing season progresses.

These same guidelines apply to any ornamental tree such as magnolias. Pruning should serve a purpose and be performed in a manner that is not detrimental to the tree's health while improving the structure and appearance of the tree.

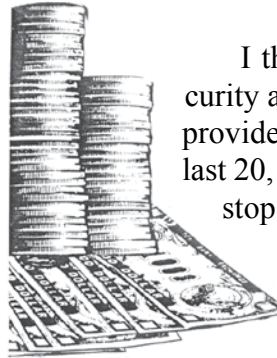

# Arts & Crafts

As you may know, the majority of our members do crochet as opposed to knitting. Therefore, I'm sharing one of our most asked-for patterns.

## Easy Wash Cloth (Crochet Version)

**Materials:** Yarn: Lily® Sugar 'n Cream (Solids: 70.9 g/2.5 oz/109 m/120 yds) 1 ball each of: Dk Blue, Lt Blue or White. Crochet hook: Size 4 mm (U.S. 6 or G) crochet hook or size needed to obtain gauge. Gauge: 17 sts and 18 rows = 4 ins [10 cm] in pat.

**Instructions:** Ch 42. 1st row: (RS). 1 sc in 2nd ch from hook. \*Ch 1. Miss next ch. 1 sc in next ch. Rep from \* to end of ch. 41 sts. Ch 1. Turn. 2nd row: 1 sc in first sc. \*1 sc in next ch-1 sp. Ch 1. Miss next sc. Rep from \* to last sc. 1 sc in last sc. Ch 1. Turn. 3rd row: 1 sc in first sc. \*Ch 1. Miss next sc. 1 sc in next ch-1 sp. Rep from \* to last sc. 1 sc in last sc. Ch 1. Turn. Rep last 2 rows until work from beg measures 9 ins [23 cm]. Fasten off.

## Fishing Club News

Don't forget that our June General Meeting is being replaced by a members only BYOB evening cocktail party to celebrate the 40th Anniversary of the LVW Fishing Club. This memorable event will be held at Willow Hall on Thursday, **June 9** from 6 to 9 p.m. Members will be served hors d'oeuvres, cake, coffee and tea while being entertained by Phil Cenicola, an outstanding DJ brought to you at great expense all the way from Toms River.

Summer's here and it won't last long so for those of you who have yet to fish the Point Pleasant Canal or the Manasquan inlet, now's your chance. Many techniques for both natural baits and lures can be used from piers or docks, especially those located in canals or rivers where there are strong currents.

The key to fishing with lures from these structures is not to become a mechanical caster. All too often anglers stand in one spot, casting over and over and reeling in with little regard for lure action or current. It is important to vary your lures. Sometimes a surface swimming plug will bring explosive strikes, particularly on slack water but when the tide is rushing in and the fish are hugging the bottom a heavy lead head cast up and across the current then permitted to settle and bounce on the bottom will bring super strikes. Still, while it is good to change lures it can be overdone. A good approach is to determine which three lures are the best suited to make a good presentation from surface to bottom and stick with those lures. In doing so you master the feel of each lure and, invariably your catch will be better. Give it a try, you are going to like it!

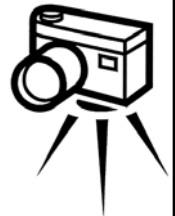

# Nature Club

## Native Plants

The March Nature Club meeting featured a presentation on landscaping with native plants. The speakers, experts in the field, provided valuable information for all of us; home gardeners, nature lovers and Ocean County residents. Mary Judge, Program Assistant/Volunteer Coordinator for the Barnegat Bay Partnership, is a co-leader of the Jersey Shore Native Plant Society, which she helped form. Kim Rowe holds a Landscape Design certificate from Rutgers University and a BS degree in horticulture. A member of the Jersey Shore Native Plant Society, she advocates for incorporating native plants into traditional home landscapes.

Native plants are those that have co-evolved as part of a community of living organisms adapted to a specific ecosystem. Native plants thrive in their local climate and soil characteristics. For the gardener, this means less work. Natives don't need fertilizer and

extra water. There are many native plants that currently beautify our village. Let's add more natives in our 5 foot areas.

Native plants benefit the environment. They provide food and shelter that meet the specific needs of the organisms living in that ecosystem, such as the birds and butterflies we enjoy. Native plants are also vital to the health of our larger community and the entire Barnegat Bay watershed. Planting natives will decrease the amount of fertilizer that washes into the bay. The native plants in coastal marshes and on barrier islands offer significant protection from storm surges.

## Earth Day at LVW

As in the past 10 years, LVW residents answered the call to honor Earth Day by cleaning up our village. Over 40 residents joined the effort and armed with gloves, bags and "pick-up" sticks or poles, went off to clean up specific areas. Many others, who could not participate on the day chosen, requested assignments and cleaned areas at their convenience. A big thank you to all who helped make Earth Day a success; those trudging around filling bags with trash, those who helped in the preparation and logistics, Maintenance and Recreation departments and to residents who pick up debris when they are out for a walk.
