**ARTICLE XV: Dissolution of Club**

In the event of the dissolution of the Ping Pong Club, its property shall be distributed to the Leisure Village West Association. Any monetary residual shall be, not less than fifty percent (50%) of which the distribution be appropriated back to the Recreation Department.

**ARTICLE XIV: Tournaments:**

B. When feasible, TWO "SINGLES" and TWO DOUBLES" INTRAMURAL TOURNAMENTS shall be held each year. A plaque indicating the winners of each division shall be updated after each tournament. A PERSON who wins his or her DIVISION in two consecutive 'SINGLES' tournaments or in two consecutive INTRAMURAL TOURNAMENTS SHALL NOT COMPETE IN THE SAME DIVISION in the next "SINGLES" or "DOUBLES" tournament, however that person may compete within a more COMPETITIVE (HIGHGER) DIVISION.

**AMMENDED TO:**

A person who wins his or her division in two consecutive SINGLES tournaments shall not compete in the same division in the next SINGLES tournament; however that person may compete in the next tournament with the condition that he or she compete within a more competitive (higher) division.

**ARTICLE XV: Dissolution of Club**

In the event of the dissolution of the Ping Pong Club, its property shall be distributed to the Leisure Village West Association. Any monetary residual shall be donated to the Manchester First Aid and Rescue Squad.

In the event of the dissolution of the Ping Pong Club, its property shall be distributed to the Leisure Village West Association. Any monetary residual shall be, not less than fifty percent (50%) of which the distribution be appropriated back to the Recreation Department.

# BYLAWS OF LEISURE VILLAGE WEST PING PONG CLUB

Amended Year, September, 2022

**ARTICLE I: Name:** Leisure Village West Ping Pong Club

**ARTICLE II: Purpose:** The purpose of the L.V.W. Ping Pong Club shall be as follows:

- A. To promote participation by residents of L.V.W. in the sport of ping pong. (Table Tennis).
- B. To encourage good fellowship and have fun.
- C. To set up tournaments within the village and with other adult communities.
- D. To arrange with the Activities Division and the Recreation director for appropriate facilities and equipment for the pursuit of the above objectives.

**ARTICLE III: Membership:** All residents of L.V.W. who are interested in ping pong shall be eligible for membership.

**ARTICLE IV: Dues:** The annual membership dues of the club shall be determined at the fall general meeting each year and will be in effect for the following year.

**ARTICLE V: Calendar Year:** The club year begins on January 1 through December 31.

**ARTICLE VI: Meeting dates:**

- A. Board meetings are held immediately prior to regularly scheduled afternoon playing time and are held as needed.
- B. Regular meetings are held at the beginning of a regularly scheduled afternoon playing time and are held as needed.

**ARTICLE VII: Officers:**

- A. Election of officers takes place in November. Officers shall serve a period of one year. An officer may serve more than two consecutive years.
- B. New officers take office on January One.
- C. In the event there is a vacancy in the office of the president, the 1<sup>st</sup> vice president shall preside.
- D. In the event there is a vacancy in the office of vice-presidents, secretary, or treasurer, the president shall appoint a member to complete the term.

**ARTICLE VIII:** The officers and their duties are as follows:

- A. **President:** The President shall call meetings of the Board and the general membership as needed to formulate and advance club activities and objectives; shall appoint committees when necessary; and also chairpersons for social events. Members will have preference in
