In the event I am injured in connection with my use of the Amenity, and such injury, including paralysis or death, is the result of the inherent risks associated with the use of the Amenity or is the result of my contributory negligence, I, for myself, my heirs, successors, executors and superiors, hereby knowingly and intentionally waive and release, indemnify, and hold harmless the Association and any and all of its trustees, officers, agents, affiliates, employees, contractors or volunteers, individually and collectively, from and against any and all claims, actions, causes of action, liabilities, suits and expenses (including reasonable attorney's fees) of any kind or nature, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my use of the Amenity. In the event of any injury, paralysis or death from the aforementioned assumed risk or my contributory negligence, I, for myself, my heirs, my successors, executors, and superiors, further agree not to sue the Association and/or its trustees, officers, agents, affiliates, employees, contractors or volunteers, individually and/or collectively, as a result of any injury, paralysis or death suffered in connection with my use of the Amenity. I attest that I am 18 years of age or older. (Initial.) The Association reserves the right to revoke my ability to use the Amenities, at any time, for reasonable cause.
